# Who we are



We are the **Health, Social Care and Sport Committee** of the **Scottish Parliament**.



A **committee** is a small group of people who are **Members of the Scottish Parliament** also called **MSPs**.



The Scottish people decide who is an MSP by voting for them in elections.



The **Scottish Parliament** makes **laws** in Scotland.



**Laws** are rules that tell people what they can or cannot do.



They protect people and make sure everyone is treated in a good and fair way.



The Scottish Parliament also checks what the **Scottish Government** is doing.

The **Scottish Government** decides how to run the country.



The Scottish Government and the Scottish Parliament are separate organisations.


# What this booklet is about



This booklet is about a new **bill**. A **bill** is a document that could become a law.



The Bill is called the **Assisted Dying for Terminally Ill Adults (Scotland) Bill**. The idea for the Bill came from an MSP called Liam McArthur.

The Bill will become part of the law in Scotland if the other MSPs agree with it.

# What the Bill is about



At the moment in Scotland, you could be breaking the law if you help a person to end their life.



The Bill is about changing the law on **assisted dying**.

For the Bill, **assisted dying** means a person gets help from a **health professional** to end their life.



For the Bill, a **health professional** is someone who is officially allowed to work in healthcare, like a doctor or a nurse.




The Bill is about changing the law so there is a way for **adults** who are **terminally ill** to have assisted dying.



For the Bill, **adults** are people who are 16 years old or more.



**Terminally ill** means you have an illness you will never get better from. The illness will lead to the end of your life.



We tell you what the Bill says below and on the next 3 pages.

**The Bill says** that to ask for assisted dying, a person must

- have a terminal illness
- be an adult
- have lived in Scotland for 12 months or more
- be able to make their own decisions
- be **registered** with a doctor in Scotland.



**Registered** means officially signed up at a doctor's surgery.



**The Bill says** that before a person decides they want to have assisted dying, they must have information about other choices, like **palliative** or **hospice** care.



**Palliative** care is care that supports people with a terminal illness to live the best life they can in the time before the end of their life.



A **hospice** is a place you can stay and be cared for when you have a terminal illness and you are close to the end of your life.



**The Bill says** 2 doctors must agree a person is **eligible** to have assisted dying.

**Eligible** means meet the rules for something.



**The Bill says** a person must make the decision to have assisted dying on their own.




2 doctors must agree the person has not been **pressured** or **coerced** into their decision.



If you are **pressured** into doing something, it means someone tries to make you do something you do not want to do.



If you are **coerced** into doing something, it means someone frightens you to make you do something you do not want to do.



**The Bill says** that if 2 doctors agree a person is eligible to have assisted dying, they can get a drug to end their life.




A health professional hands the drug to them, but they must choose to take it themselves.



**You could still be breaking the law if you help a person to end their life but don't follow the rules in the Bill.**



**The Bill says** that no one will have to help people end their life if they have a **conscientious objection** to doing this.




A **conscientious objection** is when you do not want to do something because your own beliefs mean you do not agree with it.


# Tell us what you think



We want you to tell us what you think about the Bill.




We have written some questions for you to answer. This is called a **survey**.

Thank you for helping us. What you tell us is important.




It will help the MSPs make the Bill better and decide if it should become a law.


# About the survey

This means information like their name, address or where they work.




We will not use parts of your answers to the survey if

**Offensive** means bad language that might upset people.



**Personal autonomy** means being able to make decisions and choices about your own life.

- vulnerable** people might be pressured or coerced  
**Vulnerable** means people who are more likely to be hurt or have bad things happen to them.
- assisted dying might affect the lives of vulnerable groups, like disabled people, in a bad way


# What we do with your information




**Your information** means anything you tell us that lets other people know who you are, like your name or email address.




If you answer questions in this survey, we will not **publish** your information or what you tell us in your answers.
