## Agenda item 1 – Previous minutes and matters arising

1. The Bureau agreed the minutes of its meeting on 6 January 2026.

## Agenda item 2 – Business Programme

2. The Bureau agreed a revised programme of business for the week beginning 12 January and agreed a programme of business for the weeks beginning 19 and 26 January 2026.
3. Business Managers noted that Members' Business for the week commencing 12 January would be —

## Agenda item 3 – Referral of a Bill at Stage 1

4. Business Managers agreed to recommend to the Parliament that the Local Government, Housing and Planning Committee be designated as the lead committee in consideration of the Visitor Levy (Amendment) (Scotland) Bill.

## Agenda item 4 – Timetabling of Bills at Stage 1

5. Business Managers agreed to recommend to the Parliament that consideration of the Prevention of Domestic Abuse (Scotland) Bill at Stage 1 be completed by Friday 13 February 2026.
6. Business Managers agreed to recommend to the Parliament that consideration of the Ecocide (Scotland) Bill at Stage 1 be completed by Friday 6 February 2026.
7. Ash Regan, in her capacity as Member in Charge, made representation to the Bureau concerning an extension to the Stage 1 deadline for the Prostitution (Offences and Support) (Scotland) Bill, indicating her preference that the deadline be extended to the 30 January. Business Managers then discussed the extension and agreed to recommend to the Parliament that the Stage 1 deadline for the Prostitution (Offences and Support) (Scotland) Bill be extended to Friday 6 February 2026.

## Agenda item 5 – Consideration of a Bill at Stage 2

8. Business Managers agreed to refer the Building Safety Levy (Scotland) Bill back to the Finance and Public Administration Committee for consideration at Stage 2.

9. Business Managers agreed to recommend to the Parliament that consideration of the Community Wealth Building (Scotland) Bill at Stage 2 be completed by Friday 23 January 2026.

- The Cross-border Placement of Children (Requirements, Effect and Enforcement) (Scotland) Regulations 2026.

12. Business Managers agreed to recommend to the Parliament that Rules 9B.3.5 and 9B.3.6 of Standing Orders be suspended for the purposes of consideration of the second supplementary LCM on the Biodiversity Beyond National Jurisdiction Bill.
