MINUTES OF PROCEEDINGS

Parliamentary Year 5, No. 23, Session 6

Meeting of the Parliament

Wednesday 3 September 2025

Note: (DT) signifies a decision taken at Decision Time.

The meeting opened at 2:00 pm.

- **1. Portfolio Questions:** Questions on Deputy First Minister Responsibilities, Economy and Gaelic, and then on Finance and Local Government, were answered by the Deputy First Minister and Ministers.
- **2. First Minister's Statement:** The First Minister (John Swinney) made a statement and answered questions on the Situation in Gaza.
- **3.** Palestine: The Cabinet Secretary for Constitution, External Affairs and Culture (Angus Robertson) moved S6M-18686—That the Parliament agrees with the recognition of the State of Palestine and that peace in the region must be pursued by all.

Jackson Carlaw moved amendment S6M-18686.3—

As an amendment to motion S6M-18686 in the name of Angus Robertson (Palestine), after "Palestine" insert "at the appropriate time and as part of a wider and lasting peace settlement in which the Palestinian people are free from the control of Hamas."

After debate, the amendment was disagreed to ((DT) by division: For 26, Against 83 (including 2 proxy votes), Abstentions 5 (including 1 proxy vote).

Neil Bibby moved amendment S6M-18686.2—

As an amendment to motion S6M-18686 in the name of Angus Robertson (Palestine), insert at end "; welcomes the actions taken by the UK Government to respect the jurisdiction and independence of the International Court of Justice and International Criminal Court, restore funding for the United Nations Relief and Works Agency, restrict arms sales licences to prevent breaches of international law, issue sanctions on Israeli ministers and settlers in the West Bank and commit to recognising a Palestinian state at the UN General Assembly; calls on the Scottish Government to update the Parliament on the due diligence checks carried out by Scottish Enterprise during investment decision processes to ensure that defence products are not used in breaches of humanitarian law in Gaza or elsewhere, and considers that there must be an immediate ceasefire, with delivery of humanitarian aid and food into Gaza, the release of all the hostages and a pathway to a lasting peace between Israel and Palestine, secured by a two-state solution."

After debate, the amendment was agreed to ((DT) by division: For 83 (including 2 proxy votes), Against 25, Abstentions 6 (1 proxy vote)).

Patrick Harvie moved amendment S6M-18686.1—

As an amendment to motion S6M-18686 in the name of Angus Robertson (Palestine), insert at end ", and calls on the Scottish and UK governments to immediately impose a package of boycotts, divestment and sanctions targeted at the State of Israel and at companies complicit in its military operations and its occupation of Palestine."

After debate, the amendment was agreed to ((DT) by division: For 62 (including 1 proxy vote), Against 31 (including 1 proxy vote), Abstentions 21 (including 1 proxy vote).

The motion was agreed to ((DT) by division: For 65 (including 1 proxy vote), Against 24 (including 1 proxy vote), Abstentions 26).

Accordingly the Parliament resolved—

That the Parliament agrees with the recognition of the State of Palestine and that peace in the region must be pursued by all; welcomes the actions taken by the UK Government to respect the jurisdiction and independence of the International Court of Justice and International Criminal Court, restore funding for the United Nations Relief and Works Agency, restrict arms sales licences to prevent breaches of international law, issue sanctions on Israeli ministers and settlers in the West Bank and commit to recognising a Palestinian state at the UN General Assembly; calls on the Scottish Government to update the Parliament on the due diligence checks carried out by Scottish Enterprise during investment decision processes to ensure that defence products are not used in breaches of humanitarian law in Gaza or elsewhere; considers that there must be an immediate ceasefire, with delivery of humanitarian aid and food into Gaza, the release of all the hostages and a pathway to a lasting peace between Israel and Palestine, secured by a two-state solution, and calls on the Scottish and UK governments to immediately impose a package of

6. Stage 1 Timetable: The Minister for Parliamentary Business (Jamie Hepburn), on behalf of the Parliamentary Bureau, moved S6M-18697—That the Parliament agrees that consideration of the Children (Care, Care Experience and Services Planning) (Scotland) Bill at stage 1 be completed by 16 January 2026.

The motion was agreed to.

7. Stage 1 Timetable: The Minister for Parliamentary Business (Jamie Hepburn), on behalf of the Parliamentary Bureau, moved S6M-18698—That the Parliament agrees that consideration of the Children (Withdrawal from Religious Education and Amendment to UNCRC Compatibility Duty) (Scotland) Bill at stage 1 be completed by 28 November 2025.

The motion was agreed to.

8. Approval of SSI: The Minister for Parliamentary Business (Jamie Hepburn), on behalf of the Parliamentary Bureau, moved S6M-18699—That the Parliament agrees

that the Scottish Parliament (Constituencies and Regions) Order 2025 [draft] be approved.

The motion was agreed to (DT).

9. Approval of SSI: The Minister for Parliamentary Business (Jamie Hepburn), on behalf of the Parliamentary Bureau, moved S6M-18700—That the Parliament agrees that the Scottish Parliament (Disqualification) Order 2025 [draft] be approved.

The motion was agreed to (DT).

10. Designation of Lead Committee: The Minister for Parliamentary Business (Jamie Hepburn), on behalf of the Parliamentary Bureau, moved S6M-18701—That the Parliament agrees that the Health, Social Care and Sport Committee be designated as the lead committee in consideration of the second supplementary legislative consent memorandum on the Employment Rights Bill.

The motion was agreed to (DT).

- **11. Decision Time:** The Parliament took decisions on items 3, 8, 9 and 10 as noted above.
- 12. Recognising the Impact of Chronic Kidney Disease (CKD): The Parliament debated S6M-18369 in the name of Kenneth Gibson— that the Parliament recognises the impact of chronic kidney disease (CKD) on individuals and the NHS, with, it understands, thousands of people reliant on dialysis or living with a kidney transplant, and many more at risk of progression; understands that CKD is one of the most common and resource-intensive long-term conditions but considers that it lacks a specific policy focus; welcomes the Scottish Government's work on a long-term conditions strategy and notes the belief that the Scottish Government should include CKD as a dedicated strand, with actions on prevention, early diagnosis, equitable access to transplantation, and a home-first approach to dialysis care; notes the view that increasing support for home dialysis and improving organ donation rates would improve outcomes and reduce system pressures, and further notes the belief that the Scottish Government should work with people across Scotland, including in the Cunninghame North constituency, who are living with kidney disease, as well as clinicians, third sector organisations and industry, to deliver meaningful change.

The meeting closed at 6.17 pm.
