## THE SCOTTISH GOVERNMENT'S POLICY OF EU ALIGNMENT - ANNUAL REPORTS 2024

Dear Convener

I am pleased to present to the Committee the latest reports on the Scottish Government's commitment to align with the European Union to maintain and advance high standards, where it is possible and meaningful for Scotland to do so. I also write in response to your letter of 2 October on Dr Lisa Whitten's latest independent EU Tracker Report.

Our annual reports include a draft of the Scottish Government's 2024 Statutory Annual Report on use of the power to align within the UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021 which is being laid in Parliament today.

The series of reports were first laid in the Scottish Parliament along with the draft Annual Report on use of the Continuity Act on 31 October last year. It follows agreement between my officials and Parliamentary clerks to better record and share information regarding the implementation of alignment decisions and provides greater transparency regarding the Scottish Government's commitment to align with the EU.

On 8 February, I wrote to you in response to your letter of 27 November 2023. I noted that I was pleased that our extended level of reporting met the needs of the Committee in carrying out its scrutiny function, and the finalised Continuity Act Annual Report for 2022-23 was laid in Parliament on 8 February.

In my letter on 31 October 2023 laying the draft Annual Report and the additional series of reports in Parliament, I noted that the Scottish Government will continue its proportionate approach to EU alignment. We will not become complacent and will continue to guard against risks to our policy commitment set out above. Our new processes for recording information when Scottish Government legislation is laid in Parliament and our reporting on this information in the documents laid alongside the draft Annual Report on the Continuity Act today support this approach.

Our reporting and monitoring takes place within the context of EU-UK relations. The new UK administration has made it clear that they will seek to improve relations with the EU to put the relationship on a more positive footing. It remains to be seen what this will mean in practice and we will continue to observe and to work constructively with the UK Government in Scotland's interest.

### Report Contents

- Annex A meets the statutory requirement in the Continuity Act and covers the reporting from 1 September 2023 to 31 August 2024.
- Annex B details relevant legislation passed or considered by the Scottish Parliament and consideration of EU alignment in its accompanying documentation. It covers the reporting period from 1 September 2023 to 31 August 2024.
- Annex C relates to EU proposals and legislation reviewed to establish whether it is likely to be within the scope of the powers of the Scottish Parliament. It covers the reporting period from 1 September 2023 to 31 August 2024.
- Annex D provides the current EU context after the recent European Parliament elections and the new UK Government. It looks at current and likely EU priorities in the years to come in light of Scotland's priorities

Taken together, these reports look systematically at our EU alignment policy, summarising legislation made or agreed to either in the Scottish Parliament or in the European Union, as well as setting out Scotland's response to the policy priorities of the EU. These show where the Scottish Government has taken action to align with the European Union and where it is considering the scope to do so.

Scotland is continuing to support the standards set by the European Union. Many of the policy frameworks and initiatives which we are developing domestically are, and will continue to be, influenced by the standards set by the EU.

### Scottish Parliament's Third EU Law Tracker

Thank you for your letter of 2 October. I would like to note our thanks for the ongoing research produced by Dr Whitten which continues to support and provide valuable insight and assurance to our approach.

On 1 May, I wrote to you in response to your letter of 14 March and addressed your queries including regarding terminology within our series of reports, our decision-making processes regarding alignment as well as monitoring passive divergence. The present series of reports has adjusted its terminology to reflect your feedback, and I was pleased to read that the latest report noted the improvements that we have made in the consistency and quality of our reporting. These improvements, it was stressed, have bolstered transparency and aided legislative clarity. I note that the EU Law Tracker again highlighted the potential for divergence between EU and Scots law over time and we will continue to monitor and report where this has the potential to occur.

Dr Whitten's report noted that new consolidated text versions of tertiary law can be a sign that substantive changes have been made to the 'parent' EU act, and the Committee suggested that Scottish Parliament Committees may wish to ask Scottish Ministers to provide updates on the consolidate text of relevant instruments. Certainly, the consolidated

texts detailed by Dr Whitten within this reporting period where they are likely to be within devolved competence and would have a material effect if implemented in Scotland are referenced in Annex C of our latest draft report. I think it would be useful for my officials to discuss this further with CEEAC committee clerks to establish if a rationalised approach to reporting would be of wider use to subject committees.

Scottish Government officials record EU alignment information in policy notes, relevant memoranda in support of Bills, within notifications of UK legislation made in the Scottish Parliament. This information is then reflected in the reports detailed in Annexes A-C attached. In terms of your questions on the extent of divergence on specific legislation, you will wish to consider the relevant section of the report. An enclosure to this letter contains the further information requested in your letter of 2 October on the extent of divergence in each case raised.

Finally, your letter asked if the Scottish Government distinguishes between legislative and policy alignment. The Scottish Government's policy statement approved by Parliament in 2022 notes that alignment is about maintaining and advancing the high standards Scotland enjoyed as a devolved nation within a Member State of the EU.

The Scottish Government aims to maintain policy alignment wherever possible (for example, insofar as Scotland is able under the devolved settlement and the operation of the Internal Market Act), and legislative alignment where it is meaningful and appropriate to do so. For example there will be times where the outcome of adjusting or introducing new legislation can be achieved more simply and directly by an alteration to policy. Inevitably this means there will be cases where the Scottish Government's approach to legislation may differ from the EU.

I hope you find the contents of this letter and our enclosed reports useful.

I am grateful for the ongoing approach by parliamentary clerks to the scrutiny of EU alignment policy which has helped ensure that we are providing the information required by Parliament.

REPORT BY THE SCOTTISH MINISTERS IN EXERCISE OF THE POWER IN SECTION 1(1) OF THE UK WITHDRAWAL FROM THE EUROPEAN UNION (CONTINUITY) (SCOTLAND) ACT 2021 FOR THE REPORTING PERIOD 1 SEPTEMBER 2023 – 31 AUGUST 2024 AND THE INTENDED FUTURE USE OF THE POWER UNDER SECTION 1(1) IN THE UPCOMING REPORTING PERIOD 1 SEPTEMBER 2024 – 31 AUGUST 2025

### Introduction

- 1. The Scottish Ministers lay the following report in draft in accordance with section 11(1)(a) of the UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021 ("the Act"). The draft report covers the following:
  - a) Part 1 explains:
  - the use of the power under section 1(1) of the Act during the reporting period 1
     September 2023 31 August 2024 ("the current reporting period"),
  - how that use of the power under section 1(1) contributes or has contributed towards maintaining and advancing standards in relation to the matters mentioned in section 2(1)(a) to (e) of the Act, and
  - any use of the power under section 1(1) that has been considered by the Scottish Ministers during the current reporting period.
    - b) Part 2 explains:
  - how the Scottish Ministers intend to use the power in the upcoming reporting period 1
     September 2024 31 August 2025 ("the upcoming reporting period"), and
  - how their intended use of the power under section 1(1) would contribute towards maintaining and advancing standards in relation to the matters mentioned in section 2(1)(a) to (e) of the Act.
- 2. The draft report is subject to a consultation period of 28 days. During the consultation period, representations may be made to the Scottish Ministers about their intended use of the power in the upcoming reporting period. When laying the final version of this report under section 10(1), the Scottish Ministers will also lay before the Parliament a document setting out:
  - a) a summary of any representations about the draft report made during the consultation period, and
  - b) how they have had regard to those representations in preparing the report.

### **Policy Statement**

- 3. The Scottish Government published a policy statement on 10 May 2022, in accordance section 6 of the Act, which explains their approach, the factors to be taken into account and the process to be followed when considering use of the regulation making power under section 1 of the Act.
- 4. This states that Scottish Ministers will seek to align with the EU where appropriate and in a manner that seeks to contribute towards maintaining and advancing standards across a range of policy areas. This will be achieved in a range of different ways, legislative and non-legislative. The power provided by section 1(1) of the Act is one means by which the Scottish Ministers may seek to align with EU law. It confers on the Scottish Ministers the ability to make subordinate legislation where appropriate in order to keep devolved Scots law aligned with EU law as it develops. Other means include maintaining alignment through primary legislation or non-legislative means such as statement of policy or guidance. Where secondary legislation is the most appropriate, it may be possible to align with the EU using specific domestic powers that cover the subject matter of the EU legislation.

### Report

### Part 1: Current Reporting Period - 1 September 2023 - 31 August 2024

5. How the power under section 1(1) has been used during the reporting period:

The power has not been used during the current reporting period.

6. How that use of the power under section 1(1) contributes or has contributed towards maintaining and advancing standards in relation to the matters mentioned in section 2(1)(a) to (e) of the Act:

Not applicable as the power has not been used during the current reporting period.

7. Any use of the power under section 1(1) that has been considered by the Scottish Ministers during the reporting period:

Scottish Ministers have not considered any further uses of the Continuity Act as the method by which to align within the reporting period. Information on the Scottish Government's use of other legislation to align can be found at Annex B.

### Part 2: Upcoming Reporting Period – 1 September 2024 – 31 August 2025

8. The Town and Country Planning (Environmental Impact Assessment) (Scotland) amendment Regulations 2024.

The above instrument is to be made using the powers under the UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021.

The purpose of these Regulations is to amend the Town and Country Planning (Environmental Impact Assessment) (Scotland) Regulations 2017 (2017 EIA Regulations) to ensure unauthorised Environmental Impact Assessment (EIA) development cannot benefit from enforcement time limits.

The statutory requirements for EIA originate from EU Directive 2001/42/EC. After the UK withdrawal from the EU we could no longer use the European Communities Act 1972, to make desired changes to our EIA legislation. The UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021 offers the opportunity to make desired changes, where there is no other option available. The Town and Country Planning (Environmental Impact Assessment) (Scotland) amendment Regulations 2024 wasn't laid in parliament during the alignment reporting period of 31/10/2023 to 31/08/2024, due to unexpected delays in the consultation preparation process, which had a knock on effect for preparation of the SSI.

# The Masterplan Consent Area Scheme (Environmental Impact Assessment) (Scotland) Regulations 2024

The above instrument is being made using the powers conferred by sections 40 and 275 of the Town and Country Planning (Scotland) Act 1997(a) and section 1(1) of UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021(b).

The purpose of these Regulations is to ensure a planning authority, when creating a Masterplan Consent Area scheme, makes its decision in full knowledge of the likely significant effects on the environment. An Environmental Impact Assessment (EIA) helps to identify the likely environmental effects, as well as the scope for avoiding, mitigating or reducing any adverse effects, before a decision is made.

The statutory requirements for EIA originate from EU Directive 2001/42/EC. After our withdrawal from the EU we could no longer use the European Communities Act 1972, to create new EIA legislations as had previously done as planning powers alone would not suffice. Therefore, when the concept of Masterplan Consent Area Scheme was formed, and it was understood that development proposals could be EIA development, it was necessary to use the UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021, as well as planning powers, to make these regulations.

# 9. How that will contribute towards maintaining and advancing standards in relation to the matters mentioned in section 2(1) of the Act:

This is in response to technical matters raised by the Aarhus Convention Compliance Committee concerning environmental obligations under the Convention.

### **Next Report**

10. The next reporting period ends on 31 August 2025. The subsequent report will detail the use and considered use of the power under section 1(1) of the Act during that reporting period and any planned use in the forthcoming reporting period. Our broader reporting in addition to this statutory report will also illustrate the variety of other means by which the alignment policy is being implemented.

This year's report sets out legislation and its relevance to the policy of aligning with EU law made September 2023 until 31 August 2024, covering the same period as the statutory Continuity Act annual report, 1 September – 31 August. This means there is an overlap with last year's report, as the timeframe for that report did not cover a full year but the period from September to October 2023 after new information sharing requirements were put in place.

The annex aims to give an understanding of the areas of EU proposals or legislation the Scottish Government is initially considering in scope, but the list of items is not exhaustive. # **EU POLICY PRIORITIES AND FORWARD LOOK**

This report details the European Union context and its legislative and policy priorities. It sets out the Scottish Government's high level commentary on these priorities in respect of our commitments to maintain a close, collaborative relationship with Europe and to maintain alignment with the EU where possible. The report considers the European Commission's annual Work Programme published in October 2023 and the European Council Strategic Agenda for 2024-2029 published in June 2024, during our reporting period.

# The context of and developments in the European Union

Between 7-9 June 2024 more than 350 million people had the opportunity to vote in the European Parliament elections. The European Council's subsequent appointment of Antonio Costa as its new President, and confirmation by the European Parliament of Ursula von der Leyen for a second term as Commission President, along with the nomination by the European Council of Kaja Kallas as High Representative and Commission Vice President (HRVP), heralded the start of the new 2024-2029 EU semester. There will be hearings in the European Parliament on the proposed College of Commissioners in the month of November. The new Commission will be in place by December 2024 or January 2025 with the next annual European Commission Work Programme to be published in 2025.

While the Members of the parliament are elected by the national electorates across the EU, Commissioners are nominated by national governments and the European Council is composed of national government members. The elections delivered another majority for the traditional, centrist pro-EU parties who supported von der Leyen despite an increase in support for parties on the right. At the same time, national elections in and within numerous Member States have shown a similar trend.

The 2019-2024 Commission term was headlined by legislation supporting the Green and Digital transitions. A series of strategic challenges saw the EU respond and evolve rapidly, including new areas of cooperation such as:

- EU joint procurement, EU borrowing, and new proposals for a "health union" in response to the COVID-19 pandemic;
- A strong and united response to support Ukraine against Russian's full-scale invasion;
- Collective action and the RePowerEU initiative to reduce dependency on Russian hydrocarbons;
- The cost-of-living crisis has made EU action more relevant to citizens and businesses:
- Extreme weather events have served as reminders of the urgency of tackling the existential threat of climate change.

The European Council published its <u>Strategic Agenda for 2024-2029</u> in June 2024. It sets out the EU's strategic orientations and details its priorities for the next five years:

- A free and democratic Europe;
- A strong and secure Europe;
- A prosperous and competitive Europe.

Commission President von der Leyen's campaign slogan was "democracy, prosperity and security". The 2024-29 term will also feature the next seven-year EU budget, with the Commission seeking to ensure continued support for Ukraine and economic recovery. Other

issues include Europe's defence industry, and enlargement prospects for the Western Balkans, Ukraine, Georgia and Moldova.

**On EU-UK relations** the new UK administration has made it clear that they will seek to improve relations between the UK and the EU to put the relationship on a more positive footing. The Scottish Government will work constructively with the UK Government on the work to seek improvements to how the Trade and Cooperation Agreement works, while arguing for as close a relationship as possible with the EU.

# **Scottish Government and EU alignment**

Scotland remains a proud European nation and Brexit has not changed our commitment to the EU. We will continue to be a voice in favour of mutually beneficial co-operation to mitigate the impact of Brexit in Scotland and build the strongest possible relationship with our European partners.

Scotland remains an active and constructive participant on EU matters. We engage in a number of ways, including through Scotland House Brussels and Scotland House London. Our engagement with the EU institutions and diplomatic missions bilaterally is proactive and constructive.

This Scottish Government believes the best future for Scotland is to be an independent country and as an EU member state. Until that point in time, we will maintain alignment with the EU where possible through policy making and primary and secondary legislation, including under the power granted in the UK Withdrawal from the European Union (Continuity) (Scotland) Act 2021.

This policy commitment is pragmatic, reflecting Scotland's constitutional position and our full range of devolved responsibilities. We have worked to maintain and advance high standards we share with the EU across a range of policy areas, supporting people's wellbeing and our access to the largest single market in the world.

The practical impact of the policy over the 2023-24 reporting year is detailed in Annexes A-C. Scotland's intent to align is unchanged, that is where alignment is possible, and where such alignment will have a meaningful effect on standards that support the wellbeing of the people of Scotland. Many of the policy frameworks and initiatives which are developed domestically are, and will continue, to be influenced by EU policy and legislation in this regard.

### Priorities: looking ahead to shared ambitions, challenges and opportunities

The remainder of this report looks at the European Commission's 2024 priorities as outlined in <u>Delivering today and preparing for tomorrow</u> and published on 17 October 2023.

The 2024 CWP was published at the end of the Commission's mandate less than 10 months before the EP Elections in June 2024 and amidst continuing calls for more intra-EU cooperation, unity and a more strategic focus. It was published in the context of growing global uncertainties ahead of the 'super election year' 2024 and of ongoing violent conflict in Europe and the Middle East.

The European Commission's 2024 priorities were:

- A European Green Deal
- A Europe fit for the Digital Age

- An Economy that Works for People
- A Stronger Europe in the World
- Promoting our European Way of Life
- A New Push for European Democracy

These priorities continue the focus of the previous Commission Work Programme and are reflective of our ambitions and plans as set out in the <a href="Programme for Government">Programme for Government</a> and Scotland's <a href="National Performance Framework">National Performance Framework</a>, itself firmly rooted in the international framework of the UN Sustainable Development Goals.

The shared priorities illustrate a collective understanding of the challenges and opportunities that lie ahead for Scotland and our European partners and the recognition that they be best addressed cooperatively. They priorities will shape our engagement approach with partners.

# A European Green Deal and Scotland's priorities

The Commission recognises that accelerating green transition is now of the utmost importance and urgency. The EU's Green Deal is an ambitious green transformation plan with goals such as climate neutrality, circular economy and a net-zero economy by 2050. It is also seeking to prevent environmental degradation, preserve biodiversity and create a zero-pollution environment. The Commission is continuing work on the Social Climate Fund and will launch a strategic dialogue on the future of agriculture, working together toward the transition to sustainable food systems. As part of delivering the remaining parts of the initiatives set out in 2019, the Commission was looking to focus on proposals including the electricity market design, renewable and natural gases and hydrogen, on plants obtained by certain new genomic techniques and the sustainable use of plant protection products, waste and packaging, shipment of waste, and the repair of goods, and on nature restoration.

Scotland is committed to reducing greenhouse gas emissions through a <u>Just Transition</u> to a net zero economy and society, ensuring the journey is fair and creates a better future for everyone, for example, working in partnership with marine sectors and coastal communities. We have already made progress on other priorities such as through the Circular <u>Economy (Scotland) Act 2024</u> which received Royal Assent in August enabling us to advance a zero waste and circular economy by increasing reuse and recycling rates and improving waste and recycling services. Scotland will continue to align with any protective EU measures, as protecting our high standards in animal and plant health and welfare is key to our health and wellbeing as well as Scotland's economy. Equally, Scotland's GMO (genetically modified organisms) <u>regulations</u> remain in alignment with the EU regulations currently in place.

We continue to actively monitor and review EU developments in many areas including marine and fisheries as the EU seek to deliver a number of improvements to their marine and fisheries management approach. EU proposals for reform of the EU REACH regulation and related chemicals legislation are a key concern. We want to make sure that the equivalent UK REACH regulation aligns with EU REACH where appropriate and as far as possible, within the limited powers of the specific role Scottish Ministers play in this complex UK legislation.

# A Europe fit for the Digital Age and Scotland's priorities

The Commission's proposals have reinforced the commitment to accelerate the digital and green transition in tandem, driving efficient economy while minimising environmental impact of digitalisation. The EU is recognising the opportunities as well as the need to manage risks. The EU's Digital Markets Act and Digital Services Acts are part of the foundations of a fair,

competitive, consumer friendly and safe digital environment. The EU Critical Raw Materials Act will ensure an adequate and diversified supply for Europe's digital economy as well as its green transition, prioritising re-use and recycling. The Commission further proposed the Net-Zero Industry Act to support Europe's industry in developing and taking up innovative technologies. It noted the need to progress on the single market emergency instrument, to help preserve the free movement of goods, services and persons and the availability of vital goods and services in case of future unforeseen disruptions. The Commission is also clear on the need to strengthen global AI governance.

The Scottish Government continues to work closely with commercial telecoms operators and key stakeholders such as the UK Government and Ofcom to enhance Scotland's digital infrastructure. The <a href="Connecting Scotland">Connecting Scotland</a> programme aims to ensure that everyone in Scotland has access to digital services, providing access to devices, connectivity, skills and support. We are committed to increasing digital participation and ensuring that all of Scotland is able to enjoy the social, cultural and economic benefits of a digital society.

Our ambitions on data sharing are aligned with EU Agenda For Data Mobility and we will facilitate timely access to public sector data for innovation and research, in ethical, trustworthy ways, aligned with EU data protection standards. We are facilitating the use of the data sharing powers in the Digital Economy Act 2017 by providing organisations with the necessary confidence to share personal data in compliance with data protection law.

The Scottish Government believes, as outline in its <u>Vision for Trade</u>, that digital trade should balance economic and social considerations, upholding data protection and digital rights. Our Export Growth Plan, <u>A Trading Nation</u>, identifies competitive advantages for Scotland in digital, tech, media and e-commerce. We will take advantage of opportunities from digital trade while boosting the international recognition of Scotland as an ethical digital nation. Our approach to digital trade will be set in a context of good regulatory practice and international regulatory cooperation.

Scottish Government is clear on our ambition for Scotland to become a leader in the development and use of trustworthy, ethical, and inclusive AI, as outlined in its <u>AI Strategy</u>, which we see as aligning with the principles of a Europe Fit for the Digital Age. With a world-class education, research and talent ecosystem, we are committed to maximising the economic and social benefits of AI whilst ensuring that AI and data are used in ways that are safe and responsible.

Scotland is the first part of the UK to make it mandatory to register any use of AI within the public sector through our <u>Scottish AI Register</u>. This register is a publicly accessible database which provides a range of information about the use of AI in projects developed by Scottish public bodies. Part of this involves the ongoing development of an AI governance process to help us reduce and manage risk, in line with the principles demonstrated in the EU AI Act.

### An Economy that Works for People and Scotland's priorities

The Commission noted that the EU's economy had shown resilience in the context of multiple crises including the COVID-19 pandemic and in light of the illegal Russian invasion of Ukraine. The Commission notes the importance of advancing the Capital Markets Union and to take further steps towards a Banking Union. It stressed the need to advance the proposal to improve business taxation and for a comprehensive reform of the Customs Union. The Commission emphasised the progress on the European Pillar of Social Rights and stressed the activities to address the skills gaps within several sector and youth

initiatives. The Commission will work with social partners to make our labour market more future proof in the light of deep-rooted shifts in technology, society and demography.

Making the transition to a Wellbeing Economy is a top priority for Scotland. This means building an economy that operates within safe environmental limits, and which serves the collective wellbeing of current and future generations first and foremost and incorporates the internationally recognised <a href="Community Wealth Building">Community Wealth Building</a> practical approach to economic development. Our wellbeing economy approach includes sustainable, inclusive economic growth for a purpose, to drive improved living standards, promote wellbeing, reduce poverty, and deliver sustainable high quality public services. Our economic transformation aims to fundamentally reshape our economy, delivering a just transition to a net zero, nature-positive economy based on the principles of equality, prosperity, sustainability and resilience.

We remain committed to the vision for Scotland to be a leading Fair Work nation by 2025. For those who are able to work, paid employment offers a sustainable route out of poverty. That is why payment of, at least, the Real Living Wage is all the more important now as a way of supporting those in low pay jobs through the cost crisis and is an important enabler for sustaining productive, committed and engaged workforces during these difficult times.

The Scottish Government is leading the delivery of skills planning at a national level. This work is being taken forward with the public, private and third sectors to ensure the education and skills system responds to support Scotland's economic and social ambitions. We are working to strengthen skills planning at a regional level, so local partners are empowered to better align support to regional needs and ambitions. We work towards simplifying the funding body landscape, as an enabling change to make the system easier for learners, education and training providers and employers to access and engage with. We will also lead work on: how apprenticeships can better reflect economic and learner needs; working with sector partners to consider improving careers support for all ages; and reviewing post school qualifications.

# A Stronger Europe and Scotland's priorities

Reflecting on the ongoing global tensions and geopolitical context, the Commission raises the need to address critical gaps in defence in Europe. Cooperation is at the heart of the European approach to create resilience. The EU is implementing sectoral strategies including on international energy engagement, international ocean governance, the update of the EU maritime security strategy. The Commission will continue to work with candidate countries in the Western Balkans, Ukraine, Moldova and Georgia. It will also continue to work on mutually beneficial partnerships with Africa, in Latin America and the Caribbean, Asia and Oceania.

While security and defence are reserved matters where Scotland has no devolved powers, the EU maritime security strategy also covers maritime infrastructure (ports, underwater pipelines and cables, windfarms etc), which would overlap with areas of devolved competence including marine planning and consenting particularly related to offshore wind. Policing and fisheries protection aspects of maritime security are also devolved and fall within the remits of Police Scotland and the Scottish Government's Marine Directorate respectively.

As we look to expand our generation capabilities in the coming years, the offshore renewables sector provides one of the strongest opportunities to support a fair and just transition for Scotland's businesses and communities, creating thousands of high-quality green jobs that will benefit the people and economy of Scotland. The recently published

Green Industrial Strategy has committed the Scottish Government to updating the Offshore Wind Policy Statement in 2025/26 and publishing an updated Sectoral Marine Plan for Offshore Wind Energy in 2025 to deliver the spatial planning framework for the ScotWind and INTOG leasing rounds.

The Scottish Government participates in the UK-wide, Offshore Wind Industry Council (OWIC) Aviation Management Board and the Air Defence and Offshore Wind (ADOW) Joint Programme Board on mitigating the impacts on air defence radar systems from the expansion of offshore wind. This initiative is looking at how best to provide interim and long-term technical solutions and how any technical radar solutions will be funded. It is planned that technical radar solutions will be rolled out in phases across the UK in line with demand generated by specific leasing rounds.

# Promoting our European Way of Life and Scotland's priorities

The Commission laid the foundation for a European Health Union including a new Health Emergency Preparedness and Response Authority, Europe's Beating Cancer Plan and the proposal to build the European Health Data Space. The Commission will also continue to work on achieving a European Education Area. Moreover, it will continue to strengthen the EU Security Union strategy which includes fostering law enforcement cooperation and augmenting cybersecurity including the Cyber Resilience Act and Cyber Solidarity Act to reinforce cybersecurity.

The Scottish Government believes that trade and investment in an increasingly service-based economy is tied closely to the mobility of skills and labour. Mutual Recognition of Professional Qualifications is an increasingly important consideration, both for the provision of tradeable services and the recruitment of highly skilled, qualified people. We will continue to work with the Department for Business and Trade to help facilitates access for Scotland's lawyers, architects, teachers and other professionals to international markets and ensure it respects devolved aspects of the implementation of the UK Professional Qualifications Act.

The UK and Scotland are still members of the European Higher Education Area and Bologna process and Scotland, through the Scottish Credit and Qualifications Framework (SCQF), our Higher Education qualifications are aligned with the European Qualifications Framework (EQF). We welcome the UK's association on 1 January 2024 to the vital EU programmes Horizon Europe and Copernicus. We will continue to promote Scottish stakeholder participation in Horizon Europe and work with our vital EU partners and the European Commission to maximise Scotland's research and innovation opportunities for collaboration under Horizon.

The Commission seeks to increase the integration of health, with a deeper level of cooperation on addressing risks to healthcare systems across the EU and beyond. The development of a European Health Union would be expected to introduce an increasing volume of Health-focused EU legislation. A number of the Commission's strategic priorities around health are in areas that the Scottish Government has dedicated Health strategies such as Covid-recovery, mental health, cancer prevention, workforce planning and digital care, presenting opportunities for alignment such as with the goals of our Mental Health and Wellbeing Strategy, our Tobacco and Vaping Framework: A Roadmap to 2034 which outlines decisive action to ensure smoking rates are on track to make Scotland tobacco-free by 2034, and on a European Health Data Space our ambitions of Scotland's Data Strategy for Health and Social Care. We will follow the progress on policies around those and also the European Critical Medicines Act closely to explore whether the principles underpinning these

initiatives can be applied in our policymaking and in order to continue fulfilling our alignment ambitions.

# A New Push for European Democracy and Scotland's priorities

The European Democracy Action Plan has been a pillar of the Commission's work in strengthening and revitalising European democracy. Key to building more resilient democracies are the promotion and protection of free and fair elections, media freedom and combatting misinformation. The basis of these ambitions is an independent judiciary and respect for the rule of law. Cross-border judicial cooperation is one of the building-stones. The Commission will also continue to work toward open and inclusive societies recognising the need to guarantee equal rights and protections to all groups in society. The Commission adopted strategies on children's rights, gender equality, anti-racism, Roma equality, LGBTIQ equality, the rights of persons with disabilities and victims' rights. The Commission has also focused on pay transparency and the principle of equal pay for equal work.

Scotland shares the fundamental values of the European Union – human dignity, freedom, democracy, equality, the rule of law and respect for human rights. We will continue working with all our partners and stakeholders such as the Scottish Advisory Forum on Europe to ensure that voices of all people in Scotland are heard and reflected in our priorities.

We welcome the Commission's commitment to furthering equality and specific focus on disability rights. One of our commitments is to introduce Scotland's first National Transitions to Adulthood Strategy to ensure there is a joined-up approach in order that all disabled young people can experience a supported and positive transition to adult life. We are ensuring that the voices of disabled young people are clearly heard in this vital work.

Scotland is the first UK nation to directly incorporate the UNCRC into domestic law. The UNCRC (Incorporation) (Scotland) Act 2024 makes it unlawful for public authorities, including the Scottish Government, to act incompatibly with the UNCRC requirements as set out in the Act when acting under powers derived from Acts of the Scottish Parliament. Children, young people and their representatives have a new ability to use the courts to enforce their rights. We are also committed to ambitious legislation to incorporate further international human rights treaties into Scots law, within the legislative competence of the Scottish Parliament.

# Conclusion

The Scottish Government's priorities continue to reflect the commitment we have made to remain close to the EU so as to maintain the strongest possible relationships with our European partners and working on priorities that we have in common underpinned by the values we share.

In the context of the geopolitical, economic and other challenges facing the EU and the international community, we recognise the importance of addressing these as a global community, and in doing so standing firm and united behind the key principles that define the EU as well as Scotland as a nation, including respect for human rights, democracy and the rule of law. We will continue monitoring the Commission's proposals as they develop further and consider alignment where possible and meaningful and in a manner that contributes towards maintaining and advancing standards across a range of policy areas.
