#### **Committee substitutes**

#### Purpose of paper

1. The purpose of this paper is to invite Conveners to consider the temporary relaxation of the committee substitutes rule which has been in place during the pandemic. This temporary provision allows for more flexibility in the participation of committee substitutes at meetings.

#### **Background**

- 2. The rules governing committee substitutes provide that a political party represented by 2 or more Members on a committee is entitled to nominate a Member of that party to be a substitute. In addition—
  - a member may only be a substitute on a maximum of two committees
  - a party may have only one substitute per committee
  - substitutes have all the rights and privileges that a member has (attend and participate in public and private proceedings, vote).
- 3. The rule is drafted in this relatively restrictive way to preserve consistency of membership of committees to enable committee members to build up expertise in the subject area of the committee.
- 4. While Members are expected to attend all committee meetings as far as possible, it is also recognised that there will be times that committee members will be unavailable to attend particular committee meetings. Allowing nominated substitutes to attend on behalf of committee members helps to maintain this consistency of membership as well as ensuring party balance is preserved.

#### Temporary variation of the rules

- 5. The rules were varied at the beginning of the pandemic to allow them to be applied more flexibly, allowing any Member of a party to attend a meeting in the event that a committee Member and the substitute became unavailable. This ensured that the number of Members who can participate in a meeting for a party accorded with the number Members of that party on a particular committee.
- 6. This provision was made in response to the likelihood that there would be some instances where Members would at short notice become unable to attend committee meetings, for example, through the need to self-isolate.
- 7. The temporary relaxation of the rule elapsed at the end of Session 5. It was reinstated prior to Christmas up until 11 February 2022 in response to the Omicron

variant. The Parliament, on the recommendation of the Bureau, has recently agreed to extend this temporary relaxation of the rules until Easter recess.

- 8. Looking ahead, the Parliament will need to consider whether it wishes the temporary changes to be made permanent or whether they should revert to how things operated pre-pandemic.
- 9. This is a matter for the Standards, Procedures and Public Appointments Committee but clearly Conveners, as well as Business Managers, have an interest in this matter.

#### **Next steps**

- 10. There does not appear to have been any detrimental impact to the principle of consistency of membership following this temporary relaxation of the rule. On the rare occasions where it was used, the attendance of an alternative member did not appear to have created any particular issues.
- 11. In practice, the rule was rarely used as committee members generally attended all committee meetings as normal, or the named substitute attended in their place. Meeting in virtual format made it easier for members to attend all meetings, particularly as those self-isolating could still attend.
- 12. The exception to this was the DPLRC which met in person to allow it to continue to meet during the early days of the pandemic. As this is a small committee, achieving a quorum could be an issue and so on some occasions having this flexibility avoided the committee meeting becoming inquorate.
- 13. Going forward, it is anticipated that committees will have more in person meetings and so Conveners may consider that maintaining this flexibility on a more permanent basis would be a helpful provision.
- 14. As noted, experience has shown that the principle of consistency of membership continued to apply as it did pre-pandemic with committee members (or named substitutes as necessary) attending meetings as a matter of course. This relaxation of the rules therefore appears to have provided the necessary flexibility but only as a backup.
- 15. Given that it appears that no issues have arisen as a consequence of the temporary relaxation of the rules, the Conveners Group may wish to consider seeking a revision to the rules to allow for this flexibility to be retained.
- 16. Such an approach would involve a rule change which would require a referral to the SPPA Committee.

#### Recommendation

17. Conveners are invited to share their views and experiences of this relaxation of the rules and to consider whether the Group should seek a revision to the rules to retain this current temporary relaxation of the Committee substitution rules on a more permanent basis.
