### Criminal Justice Committee - Bail and Release Bill follow up questions

Further to Jim Kerrs appearance before the committee on 25 Jan 2023, he offered to provide the committee answers in writing to the following questions:

- 1. Provide the committee with a profile of untried prisoners broken down into summary and solemn warrants.
- 2. Provide the committee with a breakdown of geographical trends for untried prisoners numbers remanded from specific courts and break down of prisoners by locality.
- 3. Provide the committee with a % breakdown of those individuals who are remanded then convicted thereafter.

I will address each question in turn to ensure absolute clarity of any data provided.

## Q1. Provide the committee with a profile of untried prisoners – broken down into summary and solemn warrants.

The following table is a 'snapshot' of the prison population as of 31 January:



SPS systems are not configured to allow the capturing of historical data in relation to untried population and trends from courts, which would support a graphic to highlight trends by individual courts. Justice Analytical Services (JAS) or Scottish Courts Tribunals and Service (SCTS) systems may be able to provide this information, however we are uncertain as to their system analytical capabilities.

## Q3. Provide the committee with a percentage breakdown of those individuals who are remanded then convicted thereafter.

SPS does not record this information. JAS may be able to provide this information, however we are uncertain as to their system analytical capabilities.
