NO ONE LEFT BEHIND – THE SCOTTISH APPROACH TO EMPLOYABILITY

I am writing to update the Committee on progress the Scottish Government has made with our approach to transforming employability support in Scotland to be more flexible, tailored and responsive to the needs of individuals and local labour markets.

I last wrote to you in October 2021 to notify the Committee that the Scottish Government will proceed with further implementation of No One Left behind from 1 April 2022.

Through No One Left Behind, we are working with partners to simplify the employability landscape and put in place locally tailored, holistic packages of support for individuals to move towards and into the labour market. In order to ensure maximum flexibility in service delivery, as well as join-up with other locally delivered services such as health, housing, justice and advice services, some elements of employability support will now be commissioned locally rather than nationally from April 2022.

Local Employability Partnerships within each local authority area involve a range of partners including Skills Development Scotland, Department for Work and Pensions, Colleges, NHS and third sector partners. Local Employability Partnerships have the flexibility to target support where it is needed based on the demands of the local labour market and the needs and aspirations of people who want support.
