## **EU EXIT LEGISLATION - PROTOCOL WITH SCOTTISH PARLIAMENT**

The Scottish Parliament agreed on the dates below that it was content for Scottish Ministers to give their consent to the UK SIs listed below, including Scottish devolved matters, as set out in the relevant notifications to the Parliament:

- 19/03/2019 Programme for Competitiveness of Small and Medium-Sized Enterprises (COSME) EU Exit Legislation
- 03/09/2019 European Grouping of Territorial Cooperation (EU Exit) Regulations 2020
- 10/11/2020 Prohibition on Quantitative Restrictions (EU Exit) Regulations 2020

The Competitiveness of Enterpises and Small and Medium-Sized Enterprises (Revocation) (EU Exit) Regulations were made by the UK Government on 16 May 2019 and the Prohibition on Quantitative Restrictions (EU Exit) Regulations 2020 on 21 December 2020, both under the European Union (Withdrawal) Act 2018. I can confirm that these SIs are consistent with the consent granted.

The UK Government decided not to make the planned *European Grouping of Territorial Cooperation (EU Exit) Regulations 2020.*
