### Who we are



We are the **Education**, **Children** and **Young People Committee** of the **Scottish Parliament**.



We meet to talk about education and children and young people.



A **committee** is a small group of people who are **Members of the Scottish Parliament** also called **MSPs**.



The Scottish people decide who is an MSP by voting for them in elections.



The **Scotlish Parliament** makes laws in Scotland.



It speaks out for the people of Scotland.



It also checks what the **Scottish Government** is doing.

The **Scottish Government** decides how to run the country.



The Scottish Government and the Scottish Parliament are separate organisations.

### What this booklet is about



This booklet is about a new **bill**. A **bill** is a document that could become a law in Scotland if the MSPs agree with it.



The bill is called the **Disabled**Children and Young People
(Transitions to Adulthood)
(Scotland) Bill.



**Transition to adulthood** means the time in your life when you grow up and become an adult.

#### What the bill is about



The bill is about ways to make things better for disabled children as they grow up and become adults.



The bill has 3 main ways to do this.



Have a National Transitions Strategy.



This is an official plan made by the Scottish Government that says how they will make better chances in life for disabled children as they grow up and become adults.



Have a **Scottish Government Minister** in charge of making better chances in life for disabled children as they grow up and become adults.



**Scottish Government Ministers** are part of the Scottish Government.



Have local **councils** make a **transitions plan** for every disabled child and young person in their area.



**Councils** are organisations that decide how services like schools and social care are run in their local area.



A **transitions plan** says what you will do after you finish school and grow up and become an adult.

Every transitions plan is different because every person is different.



The bill says the Scottish
Government will have to write a report every year about the National Transitions Strategy.



The Scottish Parliament will read the report and check the National Transitions Strategy is being followed and working well.



People and organisations talked about in the bill will have to follow the National Transitions Strategy.




This includes the Scottish Government, local councils and organisations in charge of social care.


### Tell us what you think about the bill
