HSCS Committee inquiry into health inequalities

I am writing to make you aware that the Health, Social Care and Sport Committee has today published a report of the findings of its recent inquiry into health inequalities in Scotland.

The Committee's inquiry explored evidence that the fundamental causes of health inequalities lie largely outside the health system and cross-portfolio action is therefore needed to address health inequalities.

During the inquiry, we heard a range of evidence that policy-makers operating across a wide spectrum of different policy areas need to place a specific emphasis on tackling inequalities in policy development and implementation. These areas include housing, town planning, communities, transport, social security, employment rights, social justice, and education, as well as within recovery and renewal work, and as part of public service reform.

Our report sets out areas for future action at local, Scottish Government and UK Government levels, and highlights areas where further scrutiny may be required. Throughout the report the Committee draws areas to the attention of colleagues across all Scottish Parliament committees and notes where scrutiny in these areas is already underway. Attached at Annexe A is a list of recommendations we draw to the attention of individual Scottish Parliament committees, local authorities and the UK Government.

Next steps

We hope to work with all committees across the Parliament in the future to ensure there is a cross-committee approach to scrutinising work to tackle health inequalities and the broader societal inequalities underlying them.

We would like to invite colleagues from all Parliament committees, and the Scottish Parliament Bureau and Conveners' Group, to actively consider the areas highlighted in this report as they plan their future work programmes.

The Committee's predecessor, the Health and Sport Committee, invited Conveners across Scottish Parliament committees to join a debate on health inequalities on <u>26</u> <u>March 2015</u>. We would like to invite colleagues across all current Scottish Parliament committees, and the Scottish Government, to join us in a similar debate to discuss and set out commitments to prioritise an approach to action and scrutiny that would ensure an ongoing focus on tackling health inequalities going forward.

Next Steps

I would be grateful if you could consider those aspects of our report that may be relevant to your committee's remit and how opportunities for further scrutiny in relevant policy areas might be factored into your committee's future work programme.

As a further exercise in effective cross-committee scrutiny, I would also invite you to indicate whether you would be interested in contributing to a future committee debate on health inequalities, to be organised later this year or in early 2023.

I would appreciate your response to this letter by 28 October 2022.

I look forward to hearing from you.
