Who we are



We are the **Health**, **Social Care** and **Sport Committee**.



A **committee** is a small group of people who are **Members of the Scottish Parliament**, also called **MSPs**.



The Scottish people decide who is an MSP by voting for them in elections.



The Scottish Parliament makes laws in Scotland. Laws are rules that tell people what they can or cannot do.

What this booklet is about



This booklet is about a law called the Social Care (Self-directed Support) (Scotland) Act 2013.

MSPs on the Health, Social Care and Sport Committee are looking at the law.



They want to find out if it is working well. If it is not working well, they want to find out what the problems are.

What the law is about



The law is about **self-directed support** for **social care**.



Self-directed means you choose, arrange and manage the support you get.



Social care means help with activities like

- getting dressed.
- washing.
- taking medicines.
- preparing food.
- travel.
- taking part in social activities.











Principles

A **principle** is a type of rule that helps you know what is right and shows you the best way to behave.

The law includes 4 important principles that should be part of all social care in Scotland.

Principle 1 Participation and dignity

Participation means taking part in something.

Dignity means you are accepted as you are, and other people use good words and actions towards you.

- Principle 2 Involvement Involvement means being included.
- Principle 3 Informed choice
 Informed choice means you have the right information to make good decisions about your life.
- Principle 4 Collaboration
 Collaboration is when people or organisations work together to make something happen.



Options

An **option** is a choice.



If you have an **assessment** that says you need social care, the law says your **council** must give 4 options about how you get your support.



An **assessment** is when you are asked questions to find out your health needs.



Your **council** looks after services in your area, like schools, social care and housing. Councils are also called **local authorities**.



We tell you what the 4 options are on the next page.







You get your **budget** for social care as a **direct payment**.

Your **budget** is the amount of money your council will pay for your social care.

A **direct payment** is when your budget is given to you, so that you or your carer can choose and arrange your support and manage the budget.



Option 2

You or your carer choose your support, and your council or another organisation arranges your support and manages the budget.



Option 3

Your council chooses and arranges your support and manages the budget.



Option 4

A mix of options 1, 2 and 3.



What we do with your information



Your information means anything you tell us that lets other people know who you are, like your name or email address.



If you fill in the survey, we will keep what you tell us on a system called **Citizen Space**.



We will not **publish** your information or what you tell us in your answers.



Publish means put something where everyone can read it, like on a website or in a report.



We will read all the answers we get and write a **summary**. A **summary** is a short version that tells you the main information we find out.



The summary will be published on the Scottish Parliament website. The MSPs will read the summary.



Privacy Notice

A **Privacy Notice** is a document that tells you what an organisation does with your information.
