Work programme

Purpose

- 1. The purpose of this paper is to invite the Committee to consider and agree:
 - whether to hold an informal business planning session during the summer recess;
 - its approach to the consideration of referred petitions carried over from Session 5.

Business planning

- 2. At the end of a Parliamentary session, committees generally publish a Legacy Paper to pass on the knowledge and experience, both in terms of policy and Committee working practices. The Session 5 Public Petitions Committee's Legacy Paper can be found online.
- 3. It has also become common practice for committees to hold an informal meeting during the summer recess to consider forward work programmes and to receive briefings on policy issues relevant to their remit.
- 4. Given the nature of the Citizen Participation and Public Petitions Committee, there is no specific subject area in which the Committee has overall responsibility for scrutiny of the Scottish Government. Policy-specific briefings are therefore unlikely to be of particular benefit in informing the Committee's work programme.
- 5. A business planning session would however provide the Committee with an opportunity to discuss its approach to the consideration of petitions, the Legacy Paper from its predecessor committee and the petitions process, including recent changes that were implemented during Session 5.
- 6. Importantly, such a session would also provide an opportunity for the Committee to consider the implications of its extended remit which incorporates the following addition to the previous remit of the Public Petitions Committee—

"To consider and report on public policy or undertake post-legislative scrutiny through the use of deliberative democracy, Citizen's Assemblies or other forms of participative engagement."

7. Given current restrictions, a modified approach to the logistical arrangements for any such business planning session may be required. It is suggested that one option would be for the Committee to get together in a socially distanced way in the Parliament building. This would allow any other attendees to attend either in-person or remotely. Alternatively, such a session could be conducted entirely virtually or in a hybrid format if preferred by members.

Consideration of petitions

- 8. The previous Public Petitions Committee agreed not to consider any new petitions lodged after 8 January 2021. A similar approach to the setting of a cut-off date was been taken in previous sessions. This was to enable the Committee to focus on petitions already on its work programme before the campaign recess period commenced on 25 March 2021. It was also recognised that there would have been insufficient time available to consider any written submissions received for these petitions prior to the campaign recess period.
- 9. A total of 15 new petitions were lodged in Session 5 in the period between 8 January and 25 March 2021 and will be considered by the Committee in due course.
- 10. In addition, 10 petitions that were on the previous Public Petitions Committee's work programme (often referred to as "continued petitions") were carried over from Session 5 and will be taken forward by the Committee.
- 11. Since the beginning of Session 6, a total of 5 new petitions have been formally lodged. A further 11 petitions are currently gathering signatures before they are lodged.
- 12. The Committee may also wish to note that 15 petitions that were referred to subject committees during Session 5 have also been carried over into the new session of Parliament.
- 13. The Committee may therefore wish to consider referring the 15 petitions carried over from Session 5 to the appropriate subject committees in line with the Session 5 Public Petitions Committee's recommendation. This would create more capacity for the Committee to concentrate its efforts on the high volume of new and continued petitions already on its work programme. It will also allow subject committees to take account of these petitions as part of their respective work planning processes.
- Annexe A to this paper provides a list of these petitions, together with a recommendation for a referral to the relevant new subject committee in Session 6.

Action

- 15. The Committee is invited to consider and agree—
 - To hold a business planning session during the summer recess and to indicate whether there are any specific issues members would wish to discuss;
 - To refer the 15 petitions (detailed at Annexe A) that were previously considered by subject committees in Session 5 to the most appropriate new subject committee, in line with the Session 5 Public Petitions Committee's recommendation.
