I am writing to advise that today we are publishing the final version of '[Scotland's Biodiversity Strategy: Tackling the Nature Emergency in Scotland](#)' and supporting [Delivery Plan 2024-2030](#).

Following consultation a *draft* of the Scottish Biodiversity Strategy was published in December 2022. It was published in draft to ensure that the outcomes of COP15 could be incorporated into the final strategy. An updated version was included in the Strategic framework for Biodiversity consultation (launched in September 2023) to illustrate the link between the Strategy and Delivery Plan.

The Strategy, sets out a strategic vision for a nature positive, net zero future where the loss of Scotland's natural environment is halted and biodiversity is restored, and where everyone can play their part in securing that future. The Delivery Plan is the first in a series of six-year rolling plans which set out in detail the range of actions needed to represent a step change that will accelerate the pace and scale of efforts to address the biodiversity crisis.

Both are key to the Scottish Government's Strategic Framework for Biodiversity alongside the introduction of statutory targets for nature in a new Natural Environment Bill in year 4 of this Parliament.
