Minutes of last meeting approved – no amendments or objections.

Agenda item 3

Presentation: 'Navigating the Microchip Database Network' by Phil McKinnon, Association of Microchip Database Operators (slides provided for circulation with minutes).

Q&A

- Christine Grahame MSP: suggested combining microchipping databases with registration for dog ownership. Can she give Phil's contact details to the Minister for Communities? A: yes.
- Libby Anderson: other countries are moving towards a single register why are they doing this and not us? A: some countries have taken this approach when they have set up microchipping e.g. Hungary's single database run by the veterinary association.
- Jacob Lloyd, Animal Welfare Investigations Project: concerns about microchip databases owned by convicted puppy dealers making it onto certified list. Are you making it harder to set up a database? A: yes, can report to AMDO and they can escalate to DEFRA.
- Colin Smyth MSP: not sold on not having a single database. Will it definitely be one single point of search? A: for vets, etc they would only need a single SPoS but for customers they would need to access the individual database as it would be too complex to make this into a single point.
- Scott Fryer, Battersea: we are finding more foreign microchips as they can be bought in bulk online; important that whole animal welfare sector can identify where these animals should be. Scot Gov can access the consultation info gathered by DEFRA. A: key aspect of SPoS is to ensure no duplicate registrations.
- Christine: is there a role for certification to ensure it's a genuine database? A: could use a kite mark or similar thing e.g. Europetmart.

Agenda item 4

Supplementary presentation: 'Microchipping of Pet Cats' by Stefan Blakiston Moore, Cats Protection (slides provided for circulation with minutes).

Q&A

- Christine: noted that microchips can be used on your cat flap for security. When will SAWC report? A: not sure.
- Ellie, Scottish Badgers: previously took a petition to the Scottish Parliament on welfare of wildcats and domestic cats.
- Keith Marley, New Arc Rescue: question re farm cats and feral cats. A: no plans to include these at present.

Agenda item 5

MSP Update

Colin Smyth: paid tribute to the late Eddie Palmer, Chair of Scottish Badgers who recently passed away. Ban on use of snares – gathering outside Parliament recently to mark this. Acknowledged the hard work getting to this point. Awaiting several Members' Bills progressing so a bit of a lull on that front at the moment. Keeping an eye on land reform legislation.

Christine Grahame: Welfare of Dogs Bill at stage 3 and progressing. Wants to meet dog wardens to discuss issues around training and support. Where are we with shock collars? Not law yet. Christine will follow this up. Tried to reject the XL Bully legislation and failed. Has been putting down several Written Parliamentary Questions on the subject. Asked about stink pits? Libby Anderson advised these are associated with snares which are now banned but worth checking.

[Maggie Chapman had to leave the meeting early]

Agenda item 6 – Next meeting

British Horseracing Authority re equine welfare (agreed at last meeting but couldn't make today so will present at next meeting).

Other proposed speakers for discussion:

- 1. Suggested by Christine Grahame: **National Dog Warden Association** regarding training and lone working for Dog Wardens discussed and agreed this could be one for the future but not for the next meeting.
- Suggested by Maggie Chapman to discuss animal testing: Camp Beagle and/or East Lothian Uncaged – discussed and agreed this would be of interest as not something the CPG has had presentation on before. However, it was suggested that we also invite a representative from the Home Office/legislative side to attend in order to balance the discussion.
- 3. Approached us: The University of Glasgow Dr Ilyena Hirskyj-Douglas, Lecturer at School of Computing Science, on her work on providing interactive computer systems for pets and animals. Ilyena's work has designed systems that give highly social animals agency over their environment by allowing them to communicate with animals in other zoos – discussed and agreed that members needed more information before agreeing request to present. Discussion on whether to hold meeting hybrid or online only going forward. Agreed to hold a couple of meetings per year in hybrid format to enable those who wish to attend in person to do so.

Feedback from Edinburgh Dog & Cat Home that holding meetings in evenings can be tricky as outside of normal working hours. However, it was noted that if meetings are to be held on Parliamentary business days (Tuesdays, Wednesdays or Thursdays) it has to be evenings to allow MSPs to attend as committees sit in the mornings and chamber business runs in the afternoons. Mondays and Fridays are also not ideal as MSPs have constituency business these days (MSP attendance is a priority to ensure meetings are quorate).

A range of questions were raised on topics including: alternatives to animal testing; Charles River facility in Tranent; beagles as a breed.

Noted that concerns about Charles River should be raised with your local MSPs. Christine also asked for information to be sent to her and she can share it with colleagues.

Agenda item 5 - MSP Update

Maurice Golden: hosted electric shock collars event yesterday in Parliament. Has put in amendment to 2020 Act which means ban must be implemented by 1st April. Dog Theft Bill first evidence session was at RAIC today, very positive evidence given and questioning. Stage 1 expected after summer.

Mark Ruskell: Greyhound racing bill will be introduced in Parliament end of April. No further dates as yet. Has been working with stakeholders but if anyone else wants to reach out, happy to do so.

Colin Smyth: hosted Dogs Trust event on various issues and OneKind on phasing out pig farrowing crates. WPQs on grouse moor licensing. Nature Scot has made significant change – instead of licensing for whole estate. Salmon farming debate – lack of progress since previous report.

Christine Grahame: Welfare of Dogs Act has been passed and obtained royal assent. Cross Border Pylons cutting across golden eagle project in the Tweed Valley. Happy to try again for Member's debate on pig farrowing crate with Colin.

Agenda item 4 - MSP Update

Colin Smyth MSP (verbal update given, followed up with written update copied below):

I recently hosted a drop-in event in Parliament on exotic pet welfare with OneKind, the Scottish SPCA and Born Free, marking the launch of their new report and "Don't Pet Me" campaign. The report highlights the scale of exotic pet ownership in Scotland and the serious welfare issues it causes. The campaign is calling for a 'positive list' of permitted species, tighter regulation and enforcement, a ban on wild-caught animal imports, and better public education.

I've also lodged Parliamentary Questions on species-specific licences issued by NatureScot to Forestry and Land Scotland — focusing on what species are covered, the licence purposes, and whether third parties are involved, raising questions about oversight and accountability.

In addition, I've asked what compliance monitoring NatureScot carried out during the 2024 grouse shooting season, and what is planned for 2025, given continued concerns over enforcement of the new licensing regime.

And following footage of discarded fish on the seabed, I've asked the Government what checks are made before public funding is given to vessels or companies with previous breaches of environmental rules.

Christine Grahame MSP:

Continuing to support Mark Ruskell MSP with his Greyhound Racing Bill.

On the matter of Charles River/testing on Beagles which was raised at the last meeting, MSP members of the CPGAW met recently to discuss. They agreed to write to SSPCA to request a meeting; the SSPCA have accepted the request and we are in the process of arranging a date.
