Q&A –

Broad ranging discussion on existing regulations and recently passed recommendations to ban snares from SWAC.

Impact of avian flu on birds, should foxes be shot instead of snared, is data recorded and accurate with regard to snares, query whether grouse should be imported and what impact does this have on grey partridge, do migratory birds increase the likelihood of Avian Flu. Illegal snares go unreported, success of breakaway snares used on some foxes but weight dependant,

Colin Smyth -

In the Annual Fisheries debate Colin focussed on protect and recover ecosystems. Supports the ban on snaring.

Concerned with avian flu.

Gave speech at Hunting Bill Stage 1 in October, feels the bill doesn't go far enough. Disappointed at Stage 2 the Rural Affairs, animal welfare amendments were rejected. Growing consensus that Greyhound Racing should be banned, starting with unlicenced tracks in Scotland.

Attended Greyhound debate and attended the Rural Committee debate had amendments to tighten up licensing

Hunting with Dogs Bill -definitions needed and a register of licences for using more dogs should be required.

Clean Boot Hunting Christine has concerns about whether it will lead to hounds catching foxes, could be a roundabout way of continuing hunting.

Welfare of Dogs bill is practically ready and supports responsible ownership, not purchasing from the internet etc, there is lots of support for it. Hoping for certification for purchasers.

Stewart Donald, Canine Concern Scotland Trust, discussed the Firework and Pyrotechnic legislation.

Jane Washington-Evans, Anti-Snaring discussed Clean Boot Hunting, uses Bloodhounds not Foxhounds which chase a human scent and it can be implemented in one season, young hunters are keen to take up this change, by comparison Trail Hunting can result in kills and may be banned.
