Foysol to set out future actions focusing on:

- Travel Links: Look in identifying ways to collaborate to improve connectivity with rest of the world and make Bangladesh appeal as a hot tourist destination.
- Health Inequalities: Covid inequalities, equal access to healthcare
- Employability: Looking at creating a better skilled workforce to enable
 Bangladesh to take advantage of new economic opportunities and boost
 the employment options and move away from informal jobs to ensure
 they are covered by employment rights and have access to sick leave,
 maternity, pensions etc.

- Education: Establishing Higher Education branches in Bangladesh particularly for those who cannot afford to have British Education and travel to the UK.
- Climate Change: Following COP26 in Glasgow, to discuss climate justice, mitigation
- Parliamentary Relations (Westminster and Bangladesh National Parliament): work with Westminster and Bangladesh National Parliament in unison to collaborate and discuss all the above priorities.
