Agenda item 1

Colin Smyth MSP, Convenor, Cross Party Group on Fair Trade, welcomed people to the meeting including those attending online and those attending in person. He noted that as this was a joint meeting, no minutes form either CPG were being presented for approval but that those minutes would be referred to the next meeting of the relevant CPG.

Agenda item 2

Colin Smyth introduced the first guest speaker: Prof Aziz Islam, Chair in Accountancy and Professor in Sustainability Accounting & Transparency at the University of Aberdeen Business School. Prof Islam outlined some of his research on the practices of UK high street retailers buying textile products from Bangladesh. He highlighted the importance of the textile industry to Bangladesh and also how workers in the industry can be poorly paid and exploited.

Prof Islam had carried out a survey of 1,000 suppliers in 2021 which is a sample of 25% of all suppliers in Bangladesh supplying goods to brands based in the global north. He discovered a number of unfair practices including: cancellation of orders; reducing the price paid for goods already contracted; refusing to pay for goods dispatched/in production; and delayed payment for goods already delivered by more than 3 months.

These unfair practices have contributed to job losses; wage cuts; unpaid overtime; forced labour; verbal and sexual abuse.

Prof Islam commented that legislation so far had not resolved these issues and highlighted Transform Trade's campaign for a Fashion Watchdog.

Agenda item 3

Mr Mohammad Ghayas Uddin, Community Crafts, Saidpur, Bangladesh, then spoke. He acknowledged the existence of the problems highlighted by Prof Islam along with the problems caused by climate change for the workers in the Bangladesh textile industry and their communities.

Mr Ghayas set out how he had been involved with Fair Trade for over 40 years to assist textile workers to get fair treatment and payment. He also set out how he had

set up Community Crafts, Saidpur, to give employment opportunities for marginalised women.

The company had originally produced jute goods but now had gone on to make products from upcycled sari material.

He highlighted that his company had supplied the One World Shop in Edinburgh for a number of years and he had come to Edinburgh with his colleague, Mr Mohammad Shabbir Afridi, to be part of the shop's 40th anniversary celebrations. He also reported that his visit to Edinburgh was part of a wider series of visits to buyers and potential buyers in the UK and the need to get more sales for Fair Trade products. He finished by playing a short film showing the work of Community Crafts.

Agenda item 4

Foysol Choudhury MSP and Colin Smyth MSP then chaired a discussion on the presentations. There was a question about how best to support Fair Trade and Mr Ghayas responded that consumers had to ask for Fair Trade products and support businesses that sold Fair Trade products. There was a question from Evelyn Tweed MSP in relation to what more parliamentarians could do to help. She indicated that the delegation from the CPG on Bangladesh would shortly be visiting Bangladesh and would raise the issues around the behaviour of the unfair practices of buyers from major retail businesses. Cllr Nurul Hoque Ali highlighted the problems for public bodies in implementing the Modern Slavery Act. Prof Islam promoted the importance of the Transform Trade campaign for a Fashion Watchdog and asked people to contact their MP.

The Chairs agreed that details of the Transform Trade campaign would be circulated to attendees along with links to Prof Islam's research.
