## Agenda item 1: Welcome & Introductions

Foysol welcomed CPG Subgroup members and guests to the meeting stating the CPG on Challenging Racial and Religious Prejudice will remain the same, relaying CPG Members request to have a Subgroup on Islamophobia to have a working focus group to discuss and identify various issues impacting the Muslim communities in Scotland and find solutions to remedy them. Foysol encouraged other CPG members to create other subgroups and for someone to take the lead. Foysol gave way for members and guests to introduce themselves.

# Agenda item 3: Discussing the way forward and priorities for combating Islamophobia in 2024

 Members expressed need to expand, have more events to be co-sponsored by cross-party MSPs, as well as spreading the word about the CPG and membership as a solution to raise awareness – suggestion was made to have roundtable across the nation and among communities as well as reaching out to mosques who are not aware of the CPG Group.

- Aberdeen Cllr suggested booking committee room to engage with Aberdeen communities.
- CPG Members noted the Subgroup needs to establish different strands of work to mirror the Islamophobia report thematic approach e.g. Islamophobia in the media, in education, gendered islamophobia, its intersection with poverty etc.. → CPG Secretariat suggested focusing on two or three themes to ensure they're actioned.
- Definition of Islamophobia was discussed with suggestion for Councils to adopt its definition – Glasgow Cllr Kerr was happy to try pushing for a motion.
- Cases of injustice highlighted by members noting that the Equality Act was not sufficient and that there was a need to push – questioning how to achieve this?
- Members expressed their continued concerns with wording used in media.
- Prof. Peter Hopkins updated the Subgroup regarding follow-up on the Islamophobia inquiry; confirmed he will be meeting with Education & Skills Minister, Jenni Gilruth MSP in March and has a student who is currently doing work to follow-up on media guidelines and find if they are being used and if not, why not?
- A Member raised the issue of the recent circumcision petition (concerns have been raised by Jewish & Muslim community leaders) → Foysol Choudhury MSP confirmed the petition has now been rejected.

## **Some suggestions for future Subgroup Action Points:**

- Foysol suggested for now Sub-group lead to come up with proposal to followup with action points.
- Letter to hospital chiefs to raise awareness and encourage reporting religious prejudice incidents.
- Education awareness target heads across communities report where discrimination is felt and report back to public services heads such as hospitals, university, schools..etc
- Members raised concerns of community members who fear expressing their views which often leads to underreporting - reassuring the community of their Equal rights and need to rebuild trust within the community.
- Must be reported back at Local authority level (CPG must put pressure on Councils/Local Authority level); noting Edinburgh Council has been working on it.
- Members reminded that Chief Inspector of Police Scotland admitted Police Scotland is racist last year (<u>Police Scotland Chief Constable Sir Iain Livingstone</u> <u>addresses institutional discrimination. - Police Scotland</u>);
- Call to tackle institutional racism and find ways to tap into these institutions to tackle Islamophobia and hold them to account, but also put efforts around education and awareness and some sort of judicial law.
- Further noting need to have a Strategic impact instead of recreating things that already exist

Foysol Choudhury MSP thanked all for attending the meeting and reaffirmed to the group they will be kept up-to-date and looks forward to hearing from the subgroup how they want to move forward.
