MEETING Sept 14, 2021

Seven MSPs, 49 non MSPs, 56 total MSPs Rona Mackay, chairing. Monica Lennon, Jackie Bailie, Paul O'Kane, Jackson Carlaw, Miles Briggs, Clare Adamson.

The Group was re-established and office bearers elected. It has now marked its 20th anniversary of founding in 2001 and is one of the longest running CPGs.

"Atrocious attitude to patients"

Patients had been cut out of involvement on planning new services since May 26, 2021 by Govt and Alliance, who both stopped meetings without explanation. Patient rep Liz Barrie reported as one of 10 "lived experience" patients invited by the Government-funded charity, the Health & Social Care Alliance, to serve on the Government's National Advisory Committee on Chronic Pain. (NACCP) Patients had wholeheartedly volunteered, hoping for positive results.

But Liz said it was an "atrocious" experience, used to tick boxes that patients were invited, although denied proper involvement. There was no sign of compassion or care for patients,

The Alliance had said in advance that the independent patients would be in a "coproduction" equal with officials. They would see all documents and facts to help them write service improvements. But they found no co-production, facts not given. They could not approve a report they'd worked on but were not allowed to see, being without word for six months and then sent it only after it was printed.

At a side meeting on April 27, 2021 Ms Barrie produced written proof that Clinical Priorities had not informed patients that a ban on pain relief injections had been lifted nine months before in July 2020. Patients urged discussion –refused by the chair, Dr Harden.

Later, Clinical Priorities officials sent emails threatening expulsion to two of the patient volunteers who pushed for discussion of patients left without treatment. Patient rep Kathleen Powderly said she was threatened with expulsion over "a tut or eye roll".

In contrast, no action taken against a male on the committee sending disturbing online posts to women patients who spoke up. There was no safeguarding, rules were written but ignored.

MSPs expressed shock and urged the health secretary to meet patients, The meeting passed two resolutions:

*Urging the Government to remove the Clinical Priorities Unit from involvement with chronic pain and transfer to another part of the civil service.

*Urging that return waiting times be published for 40,000 patients, as some could wait up to three years

Mesh patients

Lisa Megginson and Nancy Honeyball reported continuing lack of pain relief, and massive delays in being assessed for mesh removal. Lisa also reported that the Alliance had sought Mesh women for a role but refused her application because she was on other Groups, including the campaigners Scottish Mesh Survivors,

Mesh campaigner MSP Jackson Carlaw said the attitude to chronic pain sufferers was "a ghastly déjà vu experience, similar to what mesh campaigners endured". The mesh women at first felt dismissed, thinking that they were only there to tick boxes. Eventually they had to disassociate themselves from the report and start again. Mr Carlaw said rejection of individuals who volunteered services was also "eerily familiar".

Lidocaine patches:

There was concern that some areas wanted to cut use of Lidocaine patches to save money even for Mesh patients. The meeting invited Mr Quesir Mahmood, from the manufacturers, to tell us the NHS price. This is around £72.40 for the Versatis brand and £61.54 for Ralvo, each for 30. Patients did not think these prices should prohibit issue. Patches were all some had when treatments stopped during lockdowns.

MEETING 02 March, 2022

6 MSPs, 50 Non MSPS. Total 56. MSPs: Monica Lennon, chairing, Rona Mackay, Miles Briggs, Jackie Baillie, Clare Adamson, Pam Duncan Glancy.

Three MSPs met Health Secretary Humza Yousaf and public health minister Maree Todd on February 21 2022, a meeting requested from August 2021. The three pointed out that the original request was for patients as well as MSPs. They were Rona Mackay, Monica Lennon and Pam Duncan Glancy. Mr Yousaf promised to meet CPG patients in future.

The MSPs stressed the suffering caused by lack of treatment for chronic pain and arthritis & MSK conditions and how patient reps considered they were badly treated on the Govt advisory committee.

Mr Yousaf promised to consider a request for waiting times for return patients to be published. The Ministers also promised openness and transparency from now on,

New Pain Framework Report

Patient reps called the report "waffle" not an action plan.

It was hard to discuss a report without hard facts such as patient and staff numbers or any investment.

Patients were excluded from knowing what was in it until printed. Patient reps were elected for two years but invited to only two meetings in four months.

All meetings stopped after May 26 2021 with regular contact over. But the presence of the patients for two meetings was used to tick a box. Patients still haven't got answers to questions on what will happen to lidocaine or injection treatments.

All health boards on pain clinic results

The voluntary secretary had contacted all boards and obtained new info under FOI.

Specialist services such as outpatient injections and lidocaine infusions were again down. Fife used to be the only area which provided neither but now Ayrshire & Arran have also cut.

NHS Highland retiral.

Kirstin Laing, an NHS Highland pain patient, thanked the CPG for their support of Highland outpatient services on which she, her husband and hundreds relied. The group backed her efforts to get the Board to accept the offer by Highland pain pioneer Dr John Macleod to maintain treatments part time after he retired. The voluntary secretary said that Dr Macleod had a great service and possibly shortest waits of all, which must be protected. Secretary contacting Highland MSPs.

Guest speaker: Dr Elke Loeffler Designing and delivering effective coproduction.

Dr Loeffler is a leading expert and author on co-production. She assured the group that, properly done, it is a good way forward with equality for the public in planning all kinds of services. It should never be "top down". Patients agreed that what they went through was definitely not proper co-production.

Other work done by the CPG -

Numerous appeals for information and patient cases; Some members attended other CPGs supporting patients on shared concerns: e.g. Long Covid, Arthritis, Women's Health, Some patients compiling a detailed complaint to OSCR, the charity regulator on the Alliance on several factors.

AGM AND MEETING October 3, 2022

MSPs Rona Mackay, Monica Lennon, Miles Briggs elected coconveners Dorothy-Grace Elder elected voluntary secretary

Miles Briggs MSP, welcoming, said that after 20 years, the CPG continued to attract new members, currently welcoming new people from the Western Isles, Highlands and Borders and the cities,

Highland success He was delighted that Highland patients had won their effort to retain services from Dr John Macleod after his retiral, to which Kirstin Laing had alerted our group at our March meeting.

Meeting with health secretary and public health minister.

The meeting was told that our MSPs had tried hard to gain a meeting with Humza Yousaf and Maree Todd.

This was now set for November 7 but the health secretary again did not invite any patients, only the MSP conveners – Rona Mackay, Monica Lennon and Miles Briggs.

MSP Jackson Carlaw said this wasn't fair and that the health secretary must involve patients.

Patients pointed out that this would be the third time this year that the health ministers excluded patients. In February, a meeting was confined to MSPs, in June, he agreed to just a 45 min meeting with three patients as well as Convenersbut cancelled the meeting. November: no patients again. The conveners had pressed for patient presence and the Health Secretary promised he would meet the group at some time.

It has been made impossible for patients to continue contributing positive work to Government as officials and the Alliance have not communicated for many months,

Snooping on patient activists

The voluntary secretary produced email proof of snooping on patient activists which she obtained from Data Protection. This showed that when she asked a question of any Govt health branch, this was reported to Clinical Priorities and Govt PRs/spin doctors. No question was answered – her queries were used only to snoop on what she was doing and trying to find out, to help patients.

The emails from other Units were sent to and collected by the Clinical Priorities Unit, from whom Data Protection officials obtained them.

Example: Dorothy asked Public Health Scotland (PHS) and the "Modernising Patient Pathway" team to explain patient pathways. Both did not reply but clyped to 13 different officials what she asked. They also alerted that Dorothy and a patient from the Government NACCP group were on the radio. They told spinners in case of criticism of Govt. PHS claims to be independent, covering Scotland's health statistics and we are told to trust them. Other health units such as the Quality & Safety team, the Patient Safety Commissioner office and Clinical Priorities also clyped, without permission, to numerous other officials when DGE sent any query, however small. Some of this outrageous time waste by Edinburgh health officials was at the height of the Covid crisis in 2021, while exhausted NHS staff struggled to save lives.

Is there a black list or snoop list of patients for information denial? What is so shady about chronic pain plans that patients face spying?

Separately, Freedom of Information revealed, among other matters, emails showing that the Alliance charity had been told by a Clinical Priorities official to stop pain patient representatives "communicating" with each other outside of Alliance meetings. The Alliance agreed right away to do what the Govt official wanted and stop the patients talking. Incredible for a charity, even though they get £6 million from the public purse.

Secrecy and discourtesy

It was reported there had been no increase in transparency since the health secretary promised more openness in February. And return patient waiting times he considered will not be published.

Patients had asked, since late May 2021, what was happening with the NACCP committee they were elected to for two years. It wasn't until late July 2022 that they were told the committee had ended. No consultation.

The meeting passed two resolutions, citing that this was the fourth time they had urged for Clinical Priorities to be replaced by another part of the civil service, their latest involvement over patients being snooped on being utterly intolerable.

They also urged that the Government-funded Health & Social Care Alliance be removed from chronic pain involvement over their lack of help to patients and covert compliance with Government officials.
