There then followed a roundtable discussion on the report and the issue of textiles, sustainability and the circular economy.

6th **June 2023:** The topic for the meeting was marine pollution with presentations on the Marine Conservation Society's Beachwatch initiative, marine pollution with a particular focus on vessels at the end of their working life, the Scottish Government's Marine Litter Strategy, the Global Plastics Treaty and its impact on Scotland and a pre-recorded presentation on identification and recovery of marine litter. The presentations were followed by a roundtable discussion of the issues raised.

24th October 2023: The focus for the meeting was the decarbonisation of the waste sector with presentations on a new report from the Scottish Environmental Services Association and what action industry is taking to reduce emissions and aid wider net zero and sustainability goals across society. The presentations were followed by a roundtable discussion of the issues raised. This meeting also served as the group's AGM, during which office bearers were elected and a number of new members were adopted.
