Agenda item 2

We were delighted to welcome Anna, Sarah, Esther and Arlene from Nordic Model Now! (NMN), who gave a presentation based on their report, *The Social & Economic Costs of Prostitution & Other Forms of Sexual Exploitation: The Case for Investing in Equality*, which makes an economic case for the Nordic Model. Their presentation included three case studies of survivors in the NMN group, illustrating the massive costs to both themselves as individuals and the state.

Each survivor spoke of their lived experience and the personal impact, as well as how the normalisation of pornography and the sale of women's bodies is impacting children, young people's sexual self-concept, along with wives and partners. Anna went on to summarise some of the other wider costs to society.

We highly recommend this report and encourage everyone to download and study it.

Agenda item 4

Parliamentary and CPG Updates from the MSPs present

Rhoda Grant MSP asked **Maren Schroeder** if she had any updates on **Ash Regan's** prospective Bill.

Maren said that the official launch would take place on Tuesday 20th May 2025. **Ash Regan** will be holding a press conference in the morning, followed by an MSP drop-in session of colleagues at lunch time, finishing off with a Roundtable Event in the evening. The Roundtable Event will be inviting survivors to give their testimonies and to support the premise that the only thing to address demand is to criminalise the buyers. Maren said that members could help by sending material to go on the website, such as, case studies, videos, myth-busters.

John Mason MSP asked how we could get the NMN report out, as this would be very useful. Anna said it was on their website and pdf copies and booklets were available.

Rhoda said she was intending to have a members debate on the bill.

Jacci Stoye gave a couple of CPG updates. Unfortunately, CPG members were not able this year to support a Festival of Politics application as they currently have very full diaries. Equally, members were not able to support a CPG contingent at FiLiA, but we may be showcasing our Festival of Politics cartoon there. Unfortunately, Jacci is on holiday on the 20th May, but she would encourage members to take part in the Unbuyable Bill launch. AMFS will be lobbying MSPs for Ash Regan's bill, and Scottish members could help with this. We have access to both constituent and regional MSPs and can ask to see them individually in their constituency offices. It would be useful if we could do that and swap our findings. Finally, Rhoda has kindly sponsored me and Sasha from No Not Buying It to apply for the Parliamentary Garden Room display area. Unfortunately, it is booked up till the summer recess of 2026, but we have been told we may get a slot in the autumn of 2026, and we are on the waiting list for any cancellations.

Bronagh Andrew asked if we could do something similar with a Scottish example.

Anna said you can check publicly available data on prostitution, sex trafficking and other relevant information. With the testimonies of survivors, look up the costs of what happened to them, for example, the cost of NHS treatment and add them all up.

Sarah suggested that what might be helpful for Scotland would be to consider that the more prolonged that women are in prostitution, the more damage is done, and the costs reflect this.
