The purpose of the group is to be a forum for like-minded people who believe that the legislation surrounding prostitution and sex trafficking is out of date and in need of urgent reform.2. The Scottish Government recognise in their policy document, <i>Equally Safe</i>, that prostitution is a form of violence against women and girls, which includes other forms of sexual exploitation such as pornography, trafficking, lap-dancing, stripping, pole-dancing and table-dancing. However, their legislation does nothing to challenge the demand for the sex trade, rather it incentivises and facilitates it making Scotland an attractive destination for sex traffickers. Online pimping is legal, men who exploit women by paying for sex enjoy impunity, while women abused through prostitution can face criminal sanctions for soliciting. <p>We need a progressive legal model in Scotland that shifts the burden of criminality off victims of sexual exploitation and on to those who perpetrate and profit from this abuse. We need a model for Scotland that deters demand from men who pay for sex, holds pimps and traffickers to account and supports, rather than sanctions, victims of sexual exploitation.</p> <p>Prostitution in all its guises is fundamentally both a cause and a consequence of gender equality and has no place in a modern</p> |

Scotland. The cost of these forms of exploitation wreaks havoc on the mental, physical, and emotional health of women and girls and is a huge drain on the public purse.

3. Possible CPG overlaps could include either the Human Trafficking CPG or Men's Violence Against Women and Children CPG. However, we believe there are sufficient specific and critical issues in Commercial Sexual Exploitation, which warrant their own particular focus as we have outlined above.
4. The topics which we will be considering in the next 12 months are as follows: media support, surrogacy, the Women's Support Project's exiting event, the current policing approach to commercial sexual exploitation, the operation and regulation of lap dancing clubs, pimping websites and pornography. University students and 'sex work' kits and the platform OnlyFans which can act as an online means to recruit and exploit women for CSE.
