The aim of the Group is to ensure that Scotland has a world-class construction industry delivering best value for its clients, a safe environment on its sites and a proper career path and employment prospects for its people.

The Cross-Party Group (CPG) will be the forum for Members of the Scottish Parliament (MSPs), construction industry stakeholders and interested parties to engage directly with each other in order to raise awareness of the opportunities and challenges facing the sector and to better inform the development of policy.

We don't believe there are any significant overlaps with the purpose of existing CPG's. In the last Parliament we identified two CPG's with related purposes. These were the CPG on Housing and the CPG on Architecture and Built Environment.

The CPG on construction should be re-established because the construction industry plays a key role in how we live, work, learn and play. It is the industry which makes and enhances places and will have a central role in re-shaping those places to better suit the new ways of living and working which emerge from the Covid-19 recovery.

Furthermore, the construction industry is an important contributor to the Scottish economy – directly supporting £8.5bn in Scottish GVA and

supporting over 170,000 full-time equivalent jobs. This is c10% of the Scottish workforce, with up to a further 60,000 self-employed workers working across the sector.

In Scotland, as we look to build a fair and sustainable recovery from the pandemic, we will need the support and ingenuity of the construction industry. The construction industry, with its skilled workforce will be central in enabling Scotland to deliver on its climate change ambitions. At the same time, employers of all sizes across the construction sector will need the support of our policy makers and effective collaboration with the education sector to attract and retain skilled workers.

The CPG on Construction will be the forum for MSPs to engage with construction industry stakeholders as Scotland builds a sustainable recovery from the pandemic and works towards delivering upon its climate change ambitions.

Over the next 12 months the Group anticipates discussing the following topics:

- Carbon reduction in construction
- Embedding energy efficiency and retrofit works into the everyday practices of builders to help reduce the heat demand from Scotland's homes
- Improving the energy performance of existing warehousing, commercial and manufacturing buildings.
- Labour and skills shortages in the construction industry.
- Apprenticeship and diversity within the construction industries workforce.
