The theme of the meeting was Scottish Design and the meeting heard from 2 Speakers:

Gabriella Marcella, Founder, RISOTTO

She outlined the various levels of support that allowed her to build and sustain an independent product design business in Scotland, from a decade ago to present. Current challenges include managing the impact of Covid-19, together with Instagram changing their algorithms.

Dr Stacey Hunter, Founder, Local Heroes She provided a background to the work of Local Heroes and outlined a number of ways that

Scotland could strategically align its design offer with the international community.

There was a general discussion about Scottish Design.

The group held a meeting on the theme of Scotland's Publishing Sector and hear from 3 speakers:

Katy Lockwood-Holmes, Publisher & Chief Executive of Floris Books since 2011.

The presentation outlined the work of Floris books, and outlined opportunities and challenges faced by the organisation. It also highlighted the benefit that Publishing Scotland brings to the sector –

supporting growth and professionalisation of the industry, as well as their involvement in Booksource – distributor for a number of Scottish publishers.

John MacPherson, Director of Bright Red Publishing, an independent educational publisher based in Fife.

The presentation outlined the work of Bright Red, as well as touching on landscape opportunities and challenges. John also highlighted a need for more internships and early career opportunities for those looking to enter the publishing industry, as well as the possibility of further pooling of resources among smaller publishers, for example in the creation of co-working spaces.

Gillian Macrosson, Managing Director, Witherby Publishing Group.

The presentation outlined the history and work of Witherby Publishing Group. It concluded by highlighting the value that training from Publishing Scotland has provided – in terms of sending delegates to book fairs, information on export and their international publishing fellowship.

The group held a discussion and Q&A with speakers.

The discussion included:

The importance of Publishing Scotland in supporting and developing Scotland's publishing sector.

The gap in government support for publishers – many publishers and projects are not eligible for Creative Scotland funding or funding from enterprise agencies.

The challenges of starting out as a publisher.

Environmental considerations when making decisions about where and how to print books.

The importance of continuing to develop the talent pipeline for publishing – through training and early career opportunities.
