Isabella Goldie, CE of Deafblind Scotland noted a small working group has been put together and scheduled to meet on 21 June 2023. Professor John Ravenscroft (Scottish Sensory Centre), Angela Bonomy (Sense Scotland), Julie Ferguson (EIS) and John Whitfield have professional backgrounds and lived experience and Mike Henderson is a parent. There are 13 on the group. A draft Terms of Reference has been developed. The plan is to develop a "Declaration" on Deafblindness and look at launching it in Deafblind Awareness Week. More information will follow after the meeting in June.

Summary and update of key issues for children affected by deafness and their families and carers. Presentation attached.

Key issues include audiology waiting times, access to specialist Teachers of the Deaf, and levels of British Sign Language (BSL) across the support network, particularly friends and family, teachers, classroom assistants and allied health professionals.

Questions covered workforce planning and development issue, wider social network issues including youth workers, awareness, communication and language development and ongoing professional development of allied professionals.
