The session underlined the opportunity for Scotland to demonstrate global leadership on Fair Trade through inclusive dialogue and local action.

Speakers from Fairtrade Foundation and Oxfam GB talked about urgent challenges facing workers in global supply chains, particularly in the tea and garment sectors. The meeting led to a Parliamentary motion calling for action to improve the lives of teagrowing communities and support climate adaptation.
