### Roundtable discussion: Parental involvement and engagement of parents of children with additional support needs

### Speakers:

Emma Dougan – Edinburgh Council: Emma gave a presentation on how Edinburgh Council supports parental engagement and involvement of parents of children and young people with additional support needs.

Cheryl Burnett – National Parent Forum Scotland: Cheryl gave a talk on her work with NPFS representing parents to input into national policy on ASN, including the ASL Project Board and the Angela Morgan Review, and as chair of the ASL Network.

Actions: The group agreed to write to LAs, COSLA and ADES for more details on how local authorities are responding to the action point in the Scottish Governments ASL Action Plan to encourage local authorities to establish parent groups to support enhanced collaboration and communication on additional support for learning, and to write to the Convenor of the Scottish Parliament Education, Children and Young People Committee to highlight tonight's discussion.

### Any other business

Minutes of the previous meeting (30 Nov 22) were approved.

Patrick provided an update on the actions of the last meeting: Oliver submitted Parliamentary Questions on the Morgan Review and how it feeds into the Hayward Review/other reforms and following this informed the group Louise Hayward met with Angela Morgan.
