Agenda Item 3

Reflections on the day's visits

Stan Green fed back on the days visits, highlighting the role of horticulture in delivering wellbeing for communities. The discussion included the role of garden centres in community engagement, and the limitations of community hospital grounds contracts for green spaces. Presentation video from Trellis on health and gardening

The presentation included case studies from various projects and also outlined the obstacles and challenges faced by practitioners in therapeutic gardens. There was a discussion on the need for an accredited course in to train people to become Social Therapeutic Horticulture practitioners. Trellis' work to establish The UK Association for Social and Therapeutic Horticulture was also covered, which aims to support practitioners and provide a register of practitioners, code of conduct, and quality standards.
