

#### 1.Welcome and apologies

Paul O'Kane MSP welcomed everyone to the meeting and noted apologies made.



#### 2. Minutes and Matters Arising from last meeting

#### 3. Coronavirus Research

Roseann Maguire and Andrew Jahoda from Glasgow University talked about the Coronavirus and People with Learning Disabilities Study.

The Study looked at how people with learning disabilities and their families and carers were impacted by the coronavirus.

Linsey Kinlop represented a group of individuals with learning disabilities who called themselves the COV explorers.



The COV explorers were looking at what COVID was and how it was impacting people with learning disabilities and disabilities.

Linsey hopes that things will change for people with learning disabilities and disabilities.

Andrew talked about the findings from the last wave of the study which was collected in September to Novermber 2022.




Through the research it was found that while somethings have gotten better for people, things haven't got better for everyone.



Some felt lonely,or worried and anxious, or felt sad or down some of the time.



It was a difficult time for many family carers.



The research found that for family carers happiness was consistently lower and anxiety higher than the Great Britain average



Overall the research found that the pandemic had a significant impact on people with learning disabilities.



A video was also shared that looked at Lauren's experience during lockdown.



Pat Graham talked through Lauren's experience on the video, talking about her experience during lockdown and the difficulties she faced.



Overall the video highlighted the difficulties that many families faced during lockdown as services were stopped.



The video also highlighted that some difficulties continues as there are now staffing issues and not all services are back up and running.



#### 4. Discussion

People First said that they were not surprised by the findings.



They are very concerned as the situation is worse than it was before COVID.

Currently people's rights are not being up held.



Sandy Cruickshank talked about the need for structure across the whole of Scotland that eliminates the post code lottery of care.



William Rae talked about a man they know sent home from long stay hospital with no care in place. He said that the care system is in crisis



#### **Actions:**

- Highlight COVID research to minister
- CPG should write to Scottish COVID inquiry



#### 4. Scottish Government Update

Carmen Murray from the Scottish Government came along to provide an update on the LDAN Bill.




She discussed the scoping work for the Bull that took place between May and July 2022.



Three advisory panels were established:


- Lived Experience Panel
- Practitioner Panel
- Stakeholder Panel



Carmen discussed that at the moment the Scottish Government are in the process of developing the public consultation.



The consultation will be codesigned alongside those on the advisory panels.



The consultation will be launched in the second half of 2023.



The Scottish Government would like to hear people's views on how they can make the consultation as inclusive and accessible as possible.



So far the Scottish Government has considered definitions and who this Bill should be for.



They have also considered the potential role for a Commission/Commissioner.



#### 5. People First Update

People First shared a video update with members of the CPG on the LDAN Bill.



The video set out why the LDAN Bill is important and People Firsts key messages are.
