The actions from October's meeting were:




• Ask Minister for more clarity on the Mental Health Law Review.



 Ask Minister to come to CPG and talk about the groups concerns on LDAN, Human Rights Bill and Mental Health Law Review.






Lorne Berkley joined the meeting virtually to provide an overview of the SHRCs 'Tick Tock' Report.



It was discussed that insitutionalised care is a break of the right to independent living.




The report says that the Coming Home Implementation Plan has not done enough to get people home and in their own community.





Lorne explained that some laws in Scotland apply to people with a learning disability that allows this to be restricted.






The report says people living in in institutions are doing so for longer.

This goes against the Human Rights Act.

The report says there should be a plan for people in institutions and the Scottish Government should apologise and speak on institutions.






New Routes Home said that there are still plans to build institutions.



Members asked how do we get appropriate and affordable housing that meets peoples needs for when they leave institutions.



People First said we need an update on the Coming Home Report.


The deadline was a year ago.

PAMIS suggested we all work together as a 'Think-tank' to produce solutions.






People said agency should not be an option.

People First said they cannot believe in this day and age people with learning disabilities are still living in hospitals.



5. Supported Decision Making

The changes with the Adults with Incapacity Act had no time to introduce more supported decision making.



The principle currently says you must show you have tried to support someone to make a decision, and it has failed before applying for guardianship.



People First do not agree with this as everyone can be supported to make a decision through inclusive communication and strong trusting relationships.





5. Supported Decision Making

People First spoke on the Mental Health Act and the definition of mental disorder.

Learning disability being included is caused people to be in hospital who shouldn't be.




They also want an update on the LDAN Bill since consultation and if the bill will not just look at training as this is too narrow a focus.




Members asked will the Mental Health Law Review look at people in hospitals.






The Assembly started by saying we wanted to write to the Minister on what the plan was to end all social care charges.



He said the response was not the best and there was no direct answer to the question.







Colin from the Enable Glasgow Branch said non-residential care charges are getting worse and financial assessments are not done or not done correctly.

He said the service provider is required to collect the payment on behalf of the council.

This can be reclaimed from the council, but it is hard.



He said some people are asked to pay transport on top of their client contribution which would be provided in their Self-Directed Support Package.




Colin spoke that in Glasgow City Council there has been 2 increases in care charges.

He said it would be good to have these stalled or at least capped to stop the hardship for people.



Sonya from the Assembly said people in Glasgow whose care charges were being increased only had 4 days to complete this survey online.



The Assembly asked for an extension to allow postal responses but got no answer.

Sonya also said East Renfrewshire Council are looking to introduce social care charges.

A lot of people in East Renfrewshire have 2-2-1 care so would need to pay double.



The decision on these charges has been deterred until April 2026.




Sonya said it is still a worry because the Scottish Government were looking to remove care charges all together.





Peter McMahon spoke about his own social care charges and is scared that they are going to rise through the roof in April.



He said he does not agree that they should have access to your benefits or finances.



Sandy said everyone's bills are increasing but for people with a learning disability benefits are only going up 3% but taxes are up 6%.






Sandy also said people cannot afford social care and are going into NHS services which are free. Solution to NHS crisis is to fund social care.




Paul said there is an extra 5.2 billion in the Scottish Governments Budget but he still could not get an answer on the situation with nonresidential care charges.



People First said people with a learning disability are skint and cannot afford even 1 day of social care.



7. Any Other Business



Karen Procock would like to come to the next meeting and talk about health checks.



She would like to talk about this and health boards failing.


The group asked to hear from the minister on why most people with a learning disability have not had their health checks yet.







The Assembly is working with the Policy Team of the Scottish Government to create a booklet to make it easier to know who to contact in each health board for health checks.



They have a conference on this.



It will take place in May.
