On 17 September '25 three MSPs, fifteen in-person non-MSP attendees and twenty-two online participants heard from MalDent leads, Dr Peter Chimimba, in Malawi and Prof Jeremy Bagg in Scotland, Architects, Mr Patrick Calisse, in Malawi and Peter Lee, Architect of John McAslan + Partners in Scotland. The Scottish Government-funded MalDent project has successfully created the first Bachelor of

Dental Surgery (BDS) degree programme in Malawi, responding to there being only approximately fifty dentists in malawi for a population of 21m people.

During this meeting, members of the academic, healthcare, design and construction teams provided the background to the innovative MalDent project and an update on its status and progress.

To date, clinical dental training has been delivered in the Ministry of Health Dental Departments at Kamuzu Central Hospital in Lilongwe and the Queen Elizabeth Central Hospital in Blantyre. However, it was clear from the outset that a purpose-built teaching facility was required to make the BDS course sustainable. A significant component of the Scottish Government MalDent Project grant has funded the design work for the new clinical dental teaching facility, which also incorporates generic teaching space for other healthcare disciplines taught at Kamuzu University of Health Sciences (KUHeS) in Blantyre, Malawi. The success of the funded design programme has facilitated leverage of \$5.2m from the World Bank to support construction of the building, which is now underway.

Both the design and construction phases of the building are underpinned by a consortium of architects, engineers and surveyors from Scotland and Malawi, led by John McAslan + Partners. This represents an exciting fusion of international partnership working across healthcare, education and building construction in Malawi.

On 07 October 2025, four MSPs, twenty-two in-person non MSPs and 3 online participants heard from Olivia Giles, Founder & CEO of 500 miles.

In a fluent and naturally delivered account, Olivia Giles shared a fascinating 'warts and all' account of the past 17 years and 500 miles' transformational achievements, challenges, impact, frustrations, learning and steps towards sustainability. 500 miles supports the development and delivery of Prosthetic and Orthotic services in Malawi. They help people with impaired mobility of all kinds to get moving, as well and as independently as possible, by helping them to get access to and to be able to

In addition to the phenomenal achievements in improving the lives of so many people, despite the challenges described, the complexity of the whole story Olivia shared and reflected upon was useful and fascinating and provided a learning experience for all.

This meeting also included the CPG AGM.
