Theme: Initial meeting of the CPG on Medicinal Cannabis

- Discussion: Discussion of the purpose of the group and proposed topics for discussion.
- Consensus reached that broadly this CPG seeks to better understand the benefits of Medicinal Cannabis and recognise case studies indicating its positive impact on patients suffering from a variety of conditions. It also seeks to support patient rights to get access to medicine.

<u>Theme: Research trials and funding for prescription</u>. This session had 2 expert speakers on the topic of trials and funding.

Discussions:

- Barriers to prescribing (lack on education within medical community, a reluctance to go against institutional guidance, a lack of evidence)
- issues with supply chains, and wider discussion on access via the private sector.

A letter was drafted and sent to the Scottish Government seeking a 1 off payment for the children currently relying on private prescriptions. This was subsequently refused.

<u>Theme: Education around cannabis-based medicines.</u> This session had 3 speakers who spoke to the difficult in educating the medical profession on cannabis-based medicine:

- Dr Leon Barron Founder of the Primary Care Cannabis Network, and a member of the Medical Cannabis Clinicians Society
- Dr Sunil Arora Medical Director of My Access Clinics
- Kayleigh Ross and David Johnston PLEA

Discussions:

- Cannabis is the oldest medicine known to man, and was legal to prescribe until 1971. Therefore, concerns around safety should not be such a huge concern
- Understanding that stigma and 50 years of propaganda has resulted in cannabis being viewed as a drug of abuse, and difficult to change this persona.
- Agreement from all speakers that the medical community are at times wilfully ignorant of both the law and the evidence, and that more needs to be done to counter stigma and lack of engagement by the medical profession.

Agreement to submit a motion to parliament to debate the prescribing of cannabis-based medicines (this took place on the 5th May 2022).

Second letter sent to CMO after first letter requesting the CMO attend the meetings.

<u>Theme: Evidence in cannabis-based medicine:</u> This session had 3 speakers who are experts in the field of evidence and cannabis-based medicine:

- Professor Roger Pertwee The University of Aberdeen
- Rayyan Zahar Imperial College London & Drug Science

 Dr Lucy Troup – The University of the West of Scotland and Sapphire Medical Clinic

Discussion:

- There is significant evidence underpinning the use of CBMs for certain illnesses and ailments, and less robust evidence for other conditions.
- The hierarchy of evidence needs to be re-evaluated in light of the fact that cannabis is not a single compound, and therefore cannot be subjected to the same controlled testing as single molecule substances
- Needs to be wider acceptance of a range of evidence, and prescribing based on proof of concepts and observational trials.
- Unlikely to see MHRA cannabis products because no market in the UK so companies not interested in doing trials, except the UK company G.W. Pharma (now Jazz Pharma).
