2 Cross Party Group Business

A. Approval of 8th February 2023 Meeting Minute

The minutes of the CPGMVAWC meeting on 8th February 2023 were approved as an accurate record – proposed by LTh and seconded by MS.

Amber Cully and Alice Jackson were both welcomed as new members of the Cross Party Group on Men's Violence against Women and Children.

3 Theme: The Istanbul Treaty

- A. Eilidh Dickson, Policy & International Officer, Scottish Human Rights Commission delivered a presentation entitled 'Implementing the Istanbul Convention'.
- B. Discussion of possible follow-up Actions

There was a discussion about any benefits or drawbacks in incorporating the Istanbul Treaty into Scottish Law, including

looking to examples of other countries where that approach had been taken.

MS stressed the importance of looking at provisions for children in the Istanbul Treaty.

MS spoke about a consolidated report being compiled by Scottish Women's Aid, and encouraged members of the Group to contact Scottish Women's Aid.

MS also spoke of a meeting to consider the UK report that is due to be published by the end of June. A meeting to consider the report is likely to take place in late August.

The possibility of asking a representative from the Violence against Women and Girls Team to speak at a meeting of the CPGMVAWC was suggested.

AN highlighted an upcoming call for views on the Victims, Witnesses and Justice Reform (Scotland) Bill.

4. Member Updates

- Member Spotlight Zero Tolerance
 - The Member Spotlight was postponed, but will take place at a future meeting of the Group.
 - LTo, however drew attention to the Zero Tolerance annual Media Awards for reporting Violence against Women and Girls, which are now open for submissions.
- Women's Support Project
 - LTh updated the Group on CSE development work that was taking place, to events held by the Women's Support Project and to the development of new resources.
 - LTh also spoke about an application for funding work across a number of European countries to develop standards for exiting.

- Scottish Women's Aid
 - MS mentioned work being carried out on consultation responses.
 - FT highlighted a briefing SWA were preparing for MSPs, ahead of the debate on Thursday 22nd.
 - FT confirmed that the briefing could be circulated to members of the CPGMVAWC.
 - MS highlighted key areas to be considered, including the information available to victims, supervision orders, and the lack of information in the Bill.
- City of Edinburgh Council, Community Justice, Safer Families
 - VK spoke about the opening of the Justice Women's Centre in Edinburgh and also about training to support greater safety to women.
