## CPG ON POVERTY – AGM: Minutes 16<sup>th</sup> December 2022 11:30-12 Online - Zoom

Pam Duncan-Glancy MSP opens by welcoming members to the AGM. This is the first AGM the CPG on Poverty have conducted.

#### 1. Election of office bearers

First order of business is the re-election of office bearers.

## A) Election of convenor (chaired by Beatrice Wishart MSP)

# B) Election of deputy convenor (chaired by Pam Duncan Glancy MSP)

- Beatrice Wishart has indicated her desire to be re-elected as deputy convenor.
- Pam Duncan-Glancy MSP proposed Beatrice Wishart as deputy convenor.
- No other members have put their name forward.
- All present in agreement.
- Confirmed Beatrice Wishart MSP as deputy convenor

# C) Election of the secretariat to the CPG

- The Poverty Alliance have indicated their desire to continue as secretariat to the CPG on poverty.
- No other members have put themselves forward.
- Pam Duncan-Glancy MSP proposed The Poverty Alliance as secretariat. Beatrice Wishart seconded.
- All present in agreement.
- Confirmed Poverty Alliance as secretariat.

#### 2. Update on the work of the CPG to date and the workplan for 2023

Pam Duncan-Glancy MSP takes the group through slides running through a summary of the first year of the CPG on poverty. Notes that this year has been particularly difficult given the Cost of Living crisis and the wide ranging parliamentary activity responding to this.

Pam Duncan-Glancy MSP proposes plan for next year. Launch of stigma report by February 2023. Following inquiry will focus on rural poverty over 2023 with a report published towards December 2023.

Learning taken from this year about how to conduct inquiries and realistic goals and timescales.

Pam Duncan-Glancy MSP opened up floor for members to pose any questions or comments.

Savan Qadir – Refugees for justice asked how we can incorporate the experience of refugees and asylum seekers into the work of the CPG.

Susan Lyons – Has contacts to share experiences of rural poverty.

Bill Scott – Raised issues trying to get rural residents to talk about experiences of poverty in interview contexts. Asked members to share any contacts who may be interested. Pam Duncan Glancy said that it would be good to let the media know that the CPG will be doing work on rural poverty.

Natalie Don MSP – notes that rural poverty doesn't only apply to highlands and islands and that we need to be clear on our definition of rural poverty ahead of the inquiry.

Beatrice Wishart MSP agreed with Natalie Don's point and noted the unique experience of residents in the highland and islands. Welcomed the CPG's will work in this area

David Stewart – Asked about the role of intersectionality in rural poverty; how do we identify the highest need for individual support. Ruth Boyle highlighted the desire of the CPG to take an intersectional approach to our work and that this is something that has been considered within the stigma inquiry. Pam Duncan-Glancy MSP – raised the work of the SJSS committee on their inquiry into parental employability

Paul McLennan MSP – noted experience of lone parents within the context of rural poverty. Ruth Boyle highlighted that the experience of lone parents is something that is covered in the stigma report.

Carol Mochan MSP – Noted the good work done by the CPG and expresses keenness to be involved this year, particularly on intersectionality.
