### Agenda item 1 - Welcome and Apologies

Stuart McMillan MSP welcomed everyone to the meeting.

# Agenda item 2 - Minute from Meeting on 14<sup>th</sup> December 2021

The minutes were approved as an acceptable record pending changes from Sarah Kennedy.

## Agenda item 3 - British Marine Scotland Update

SL provided an update and outlined the following:

- The Calor Gas sporadic supply continues to be a problem in Scotland.
   Marine Scotland have written to Calor Gas but no response has been received as yet. SL asked whether CPG would be willing to write to Calor Gas to support the case. Action/Decision: This was agreed and SL will send on text from the letter that was submitted by British Marine.
   Action: SMCM to write to Calor Gas on behalf of CPG.
- Ross Wombell reported that he has engaged with the Calor Gas and they
  have informed him that they are trying to supply critical areas in residential
  areas for home heating. They will start to supply small cylinders for tourism.
   Action: RW will share contact details of his contact in Calor Gas.
- GP stated that new cylinders are in short supply, but there is expected to an increase in non-critical supplies over the next 2 months.
- Red White diesel information has been circulated to marinas and boatyards and they have asked for flexibility from HMRC. Alternative fuels are more expensive.
- There will be a continuation for Returned goods relief on boats coming back from UK waters outside UK and this will not be time limited.
- British Marine Scotland have continued with a focussed approach to skills and careers to fill the skills gap. A labour and skills survey has been issued to members and non-industry sectors and they are aiming to get consistency so in order to obtain trackable data.
- Work is taking place with colleges and training providers and British Marine UK are offering training and support to other regions as a priority.
- There have been 2 strategic appointments to the board.
- Action: SL will keep the members informed and will share a copy of the Labour and skills survey results once available.

- British Marine have a national conference on 15<sup>th</sup>/16<sup>th</sup> March 2022. The focus will be on innovation and barriers to success, post pandemic and Brexit and will also discuss environmental opportunities and this fits with the themes within Giant Strides. SMCM asked if there will be a report from the conference that could be circulated. Action: Ross Wombell confirmed that this would be produced and will be circulated to members.
- SMCM asked what work has been undertaken about the skills and labour gaps and has there been work with Skills Development Scotland and have social media channels be used to promote? SL stated that they are looking at retraining and bringing people in from other sectors and from schools.
- SMCM asked has BM Scotland considered going along to career fairs. SL stated that their intention is to cover stalls at careers fairs and are intending to go to schools to give them an overview of the industry.
- SMCM gave an example of a project in West College Scotland where there has been real success in developing young people and has encouraged them into vocations that they would not have considered and it also assists with other aspects of learning. SMCM suggested that if it can be badged up properly with local colleges then this could be the hook. SMCM stated that it can be difficult for small businesses with modern apprenticeships and it is a complex pattern. We need something that will switch the light on. SL gave an example of a successful boat project in London that resulted in the group competing in Cowes Week and winning many awards and bringing young people in.
- SK stated that there is an initiative "Developing the young workforce" that would be a good avenue to pursue and suggested that this would be a way to link in with University of Highlands and Islands. Glencoe Boat Club and Lochaber Hope are building skiffs and involving young people and this could also be linked up. Action: SK to provide further details to SL.
- A Rendle stated that Scottish Coastal Rowing Association have just added their 214th skiff onto their register and Castle Brae has just completed building a skiff.
- AR stated that he attended a meeting with the Scottish Tourism Alliance where discussion took place on "Developing the young workforce" and suggested contacting Marc Crothall who can hook into that process with active funded programmes.
- DT reported that there is also the MCR project, where young people in schools are mentored by an adult outwith the schooling system. The project is also seeking work experience placements.

Action: DT will pass on details to SL.

### Agenda item 4

#### Review of CPG Terms of Reference

SMCM asked if members had any changes that they would wish to be made to the current Terms of Reference.

Action/Decision: The CPG members agreed that no changes were required and approved the current Terms of Reference.

### Agenda item 5

## Update from Scottish Canals on Moorings and Licence Fees

JS provided a presentation on "Five year pricing review of moorings & licences"

There then followed an opportunity for questions:

- GP asked for feedback on how they are finding the balancing act e.g., if you price too low, then there is far too much demand but if you price too high it will put off users. JS explained that they use the market indicator as a clear guide for pricing. In 2016 they took the recommendations to cap it at £100. They have very few vacancies and very high uptake in moorings and this gives them an indication that they in the right ball park. They are committed to providing as many mooring sites as they can. The market is not as mature as south of border and need to keep the demand alive and fund the creation of new moorings.
- RM stated that they are now 5 years in from introducing the methodology and has remained fairly steady. The residential moorings are at full capacity. It is about keeping that balance so that we do not tip too far one way. Demand has remained strong and steady and the prices mut be in the right zone as people are coming to us and there is a waiting list. There is a drop in demand in Crinan due to covid and the current operation of 5 days per week, once this has been increased to 7 days the berths will fill.
- GP asked is the same methodology applied to transits. RM stated that they
  have reviewed the pricing of the transit and it has increased gradually and has
  been reviewed again. RM further explained that there are 3 areas that are
  looked at: the mooring charge, navigation licence and transit charge. These
  all are balanced and are working fairly well. It has been a difficult couple of
  years due to Covid but they want to see increase in usage again in Crinan
  and Caledonian Canals. The Lowlands Canal uptake is low and are keen to
  open this back up again.

• SK on behalf of Hamish Loudon raised concern about the high Fort William prices and explained that it is cheaper to get storage in Craobh Haven. SK asked what is the plan to encourage people to berth over winter. RM explained due to the construction works that are taking place this has been an issue but the demand still remains strong. They keep a close eye on the wintering charges however this is not part of this review and it is decided based on the localities and they try to keep them as fair as possible.

### Agenda item 6 – Presentation from Alan Rankin

AR outlined his presentation providing an overview of the work of Sail Scotland.

There then followed an opportunity for questions.

- SMCM asked if the sterg will continue? AR stated that they are keen that it continues.
- RM thanked AR for his presentation and the details of the final campaign before he departed Sail Scotland. RM asked if Sail Scotland are recruiting for replacement as the work that he does is critical and it is a great baseline for rebuilding after Covid. AR stated that Daniel Steel will be undertaking a dual role with Ayrshire Council and Sail Scotland and due to his previous time in the role will be able to hit the ground running. SL asked if this will be shared with the group. AR confirmed that there will be a press release.
- AR also reported that there is going to be a top up from the Scottish Government for destinations.

Action/Decision: SMCM suggested inviting the Ivan McKee MSP, Minister for Business, Trade, Tourism and Enterprise to the next meetings on either 14<sup>th</sup> June or 28<sup>th</sup> September The group agreed.

SMCM gave his grateful thanks to AR for all that he has undertaken for Sail Scotland, the marine tourism sector and the Cross Party Group and wished him a long and happy retirement.

# Marine wildlife disturbance Joint campaign Whale and Dolphin Conservation and Marine Scotland – Sarah Dolman

Sarah Dolman reported on the issues with marine wildlife disturbance and that they

are working with many stakeholders to raise awareness. They have pulled together a social media toolkit ahead of the Easter holidays to assist. SD stated that they would welcome the support from the CPG to put out positive messaging in social media posts, on websites and in magazines.

SMCM also suggested that they also speak to MSPs in CPG to help with local newspaper posts.

J Minto MSP reported that she visited the Crinan Canal as an MSP and stated that we have so many marinas around the coast and need to take advantage of every opportunity to sell what we have and the beautiful opportunities that are out there. There are whales, dolphins and porpoises washed up on the beaches and we need to make people aware. We require to invite Whale and Dolphin Conservation to come out to the constituencies and tell these wonderful stories as they are very uplifting presentations.

Action: SMCM asked members to engage with their MSPs and ask them to come out and see you to find out what is going on your areas.

### Scalasaig harbour on Colonsay

GR reported that a situation arose at Scalasaig Harbour where they were going to ban anchoring, however a small group worked on this and have discussed alternative ways of solving this issue.

### Marine litter strategy consultation

GR reported that the consultation is open until 22<sup>nd</sup> March and encouraged members to make contributions.
