Agenda item 4 CPG Work Plan and Future Agenda Topics

Agenda Item 5 - Coastal change from the Dynamic Coast project – Dr Alistair Rennie

Dr Alistair Rennie provided an outline of the Dynamic Coast Project Project and there then followed an opportunity for questions.

- SK introduced herself and said that she would look at the website as she had
 not been aware of it and it would be good to look at the interactive maps. AR
 stated that they have taken a risk-based approach and there is soft coast in
 some areas but there is risk on rocky shores. EW reported that there are
 engineered shores and they are worth looking into it as another phase of
 work.
- SMCM asked if this process if local community groups had been made aware as we are very keen to do our part but do not want to step on the toes of the local authorities.
- AL asked about the 6 case studies asked if it is engineering nature-based solutions. AR stated that local authorities were asked to submit applications and there was half a million pounds allocated.
- Adaptation plans have been drawn up and there are 6 or so case studies across the piece and they can use what would work best in their area. Funding will start in the next financial year 2023-24. We are trying to understand what is going on to put in short term measures, through to long term plan. CMCF asked does it take into account the risk assessment and demands on population? AR stated that they are developing the evidence to support all inhabited islands and erodible shore should be consistent across Scotland so whoever wants to take this on can access this.. Interactive maps are available on the Dynamic Coast website.

SMCM thanked Dr Rennie very much for an excellent presentation.

Agenda item 6 - British Marine Scotland Future Work Plan - Martin Latimer – Crown Estates Presentation invitation

Martin Latimer provided an update and outlined the following:

The Sailing tourism in Scotland report is close to completion and it will then be detailed at an event on 8th March 2023 at the Scottish Parliament. The report is showing 12% growth in employment and 15% in output. This is the fourth cycle that we have showed continual growth. Then CPG will get sight of the report in advance. The funding partners will get draft in December 22.

It is our intention to launch the skills survey. There are some worrying factors: 60% of our workforce are over 50and we need to make allowance for retirement. Growth projects are planned to get new skilled workforce. The meeting in February will provide a further briefing. Conversations are also taking place with Skills Development Scotland.

JS stated that the reception will be used for sharing the detail and then will look at how interpret to move towards actions and test the thinking through the CPG. The reports have been very powerful for driving forward investment and indicating great direction of travel and this should put us in good shape for the coming few years.

ML stated that this will trigger a whole rath of work on skills education and training and this will be taken forward to schools and colleges. **Action: ML to have a discussion with SMCM offline re arrangements for the event.** SMCM explained all MSPs will be invited as standard practice for events.

Agenda item 7 - AOCB/Future Business

Hybrid Meetings

A discussion took place on the possibility of having a meeting face to face in the Scottish Parliament with option for people to join in remotely. SMCM stated that there is one room in the Parliament that would allow for hybrid meeting to take place and arrangements will be put in place.

Business Rates Evaluation

SL reported that there has been an announcement of business rates evaluation taking place. There will also be energy costs support after 1st April 2023. SMCM reported that the SME's Westminster budget will be published on 15th December.

SMCM reported that the Scottish Government has Barclay review has commenced and all recommendations have been taken onboard apart from business rates. DAM stated that it has allowed for negotiation.

SL stated that the level of detail has increased in a short timeframe and are awaiting further detail in approx 10 days' time.

Commercial Boat Operators Association

J Mosse explained that the CBOA stands for Commercial Boat Operators Association. This is often mistakenly written as Commercial Boat **Owners** Association and is relatively new to Scotland (JM has been rep for about a year) but there is a long-established association south of the Border, representing most of the large (and small) inland waterways freight operators. **Action: JM requested that Scott Johnson and Gordon Daly be included in any corresponded with Peel Ports. GD stated that he would raise this and SJ offered his assistance.**

SJ stated Waverley Excursions have not had support because they do not fall into the category that is eligible and have a £500K shortfall. £150K has been raised by surcharging to customers.

GD asked SJ about the draught for the Waverley and how much depth had been lost on back. Due to the loss of Helensburgh Pier, they are now unable to come alongside due to closure of pier (3ft 8 draught, 1 metre).
