Nine members of the group were present, and two Scottish Government civil servants in attendance. Invited speakers were Cara Cooper and Rod Finan (GIRFEC), and Claire Ross (New Ways For Families).

### Agenda Item 1

GETTING IT RIGHT FOR EVERY CHILD: Cara Cooper and Rod Finan from the GIRFEC team presented an overview of the development of GIRFEC, including information on its links to other policy areas; the recent consultation activities and planned next steps.

### Agenda Item 2

NEW WAYS FOR FAMILIES: Claire Ross, Training Manager, Shared Parenting Scotland. Shared Parenting Scotland is piloting a coaching programme called New Ways For Families that empowers parents with the skills and insight to find their own way to put their children ahead of their urge to battle each other.

## Agenda Item 3

PARENTING APART: Rosanne Cubitt, Head of Practice for Family Mediation and Relationship Counselling at Relationships Scotland, explained the Parenting Apart sessions run by Relationships Scotland and its distinctive approach to encouraging parents to gain perspective on issues that arise in separated parenting.

A further meeting took place on 8th November 2022.

Nine members of the group were present. Three members of the Scottish Government civil service and an MSP staff member were in attendance. Two guests were invited to make presentations: Gary Clapton, Senior Lecturer in Social Work at the University of Edinburgh, and Professor Alison Koslowski.

## Agenda Item 1.

The Invisible Man. Gary Clapton is a former children and family social worker and a senior lecturer in social work, with a particular interest in representation and lack of representation in social work and public health imagery. He published his report "Where's Dad?" for Fathers Network Scotland 10 years ago and talked at the meeting about progress since then.

#### Agenda Item 2.

How Scotland could benefit from new EU legislation on family leave and work-life balance. Professor Alison Koslowski is lead Editor of the International Review on Leave Policies and Research, which reviews parenting leave policies across 49 European countries. She explained how new legislation has improved parental leave rights for mothers and fathers, and how far behind the UK has fallen/how much an independent Scotland would have to catch up.
