| 1) Purpose of the Group: <p>The Group will identify, examine and promote policy and practice that supports parents in sharing parenting responsibilities. It will consider how gender stereotypes can be tackled in the pursuit of a better understanding of what we need to do to ensure the best possible childhood and most promising adult life for Scotland's children. It will provide a forum for MSPs, stakeholders and other interested parties to engage directly in dialogue to inform policy developments and practice which impact on parents sharing responsibilities for the role and support networking on this topic.</p> |
| (2+3) Supporting explanation + overlaps: <p>While there is general public support for the notion that in general children benefit from the emotional, material and psychological support of both their parents not only after divorce or separation but also within 'intact' families. However, in practice there are disincentives within policy and practice that stand in the way of achieving that for Scotland's children - from resistance to equal parental leave at work to the adversarial precepts of resolving disagreements when parents no longer live together. While other cross party groups touch on similar issues the distinctive contribution of this cpg is to pull all the threads together to identify the disincentives in culture and practice in place in Scotland that hold us back from Getting it Right for Every Child. gather experience and hear proposals to tackle the disincentives to sharing parenting in Scotland and hear from contributors from other countries on the positive alternatives that are established there.

4) Upcoming topics:

We have prospective contributions already drawn up from a retired family court judge in Israel where issues are resolved very differently; a university researcher whose project gathered the views and experience of young people about their experience of shared parenting. It is rare in Scotland to hear the voices of young people themselves; from a US campaigner on behalf of 'Moms for Shared Parenting' who sees shared parenting as a liberation from gendered custom and practice.

Whatever the outcome of the UK Supreme Court on the UNCRC Incorporation Act the Scottish Parliament is committed to embedding the Convention in public practice. We will spend time on the implications of UNCRC and on the Family Law Modernisation Strategy.
