A discussion followed about the three presentations. Attendees made the following points/questions:

- It is so important to foster trust on all "sides" of the wildlife management debate wherever possible.
- waders are still in severe decline across Scotland. Although grouse moor management can help, we need more action elsewhere in Scotland to help wading birds.
- to what extend does NatureScot look abroad for inspiration on policy? And could Scotland make the same mistakes as Germany re predator control? Answer: it does look abroad, and is always learning from approaches elsewhere.
- Concerns about greenwashing.
- What efforts has Germany made to bridge the gap between the hunting community and conservation interests? Answer: some but there remains ample room for improvement.
- Are restored peatland areas (particularly those that can revert to near natural blanket bog) not a real positive for expanding good wader habitat? Answer: yes.
- Carbon markets are evolving and include lots of opportunities. There are public objectives for carbon sequestration and on biodiversity in Scotland but shooting is not part of those objectives. Is the situation similar in Germany? Answer: attitudes to shooting are similar in Germany.
- Germany is known for having progressive access rights are there problems there with access leading to disturbance of ground nesting birds: Answer – perhaps - but this can be discussed via email in more depth.
- Both Daniel and Jessica agreed to have their email address shared for any follow-up questions or development of their answers.
