COP 26 (Sunday 31 October to Friday 12 November 2021)

- CPGT / Office of Tibet meetings, 4 & 7 November
 ACH met with Representative Sonam Tsering Frasi and Secretary Tsering
 Tsomo at the Scottish Parliament Building in Edinburgh on 4 November.
 RG and MV met with Representative Sonam Tsering Frasi and Secretary
 Tsering Tsomo at the Green Hub in Glasgow on 7 November.
- Tibet's Climate Crisis: Critical Lessons for Global Climate Policy, 4
 November
 A panel discussion featuring MM, together with Dr Tobias Bolch, a
 glaciologist from St Andrew's University, Dr Lobsang Yangtso from the
 International Tibet Network and Dechen Palmo from the Tibet Policy
 Institute.
- The Climate Catastrophe the World Ignores, 7 November
 A panel discussion featuring TC, together with: Golog Jigme, a Tibetan filmmaker, activist and former political prisoner; Pema Doma, Campaigns Director, Students for a Free Tibet; Cy Wagoner, Creative Resistance Coordinator, NDN Collective. MV had also been scheduled to speak at this event but unfortunately had to withdraw.
- Tibet's Climate Crisis Can No Longer Be Ignored
 As COP 26 drew to a close, the CPGT issued a statement with its
 observations on the conference and recommendations for future climate

policy. This was published on the CPGT website, circulated to press and shared via social media. The briefing paper issued by the Tibetan delegation at COP 26 was appended to the CPGT statement.

Beijing Winter Olympics Campaign

CPGT MSPs and former MSPs were active in campaigning against the Beijing Winter Olympics. This included participating in calls for a diplomatic boycott, which was initiated by the Inter-Parliamentary Alliance on China (IPAC), issuing statements and asking questions of the Scottish Government. On 7 December we were able to announce that the Scottish Government had confirmed it would not be sending any representatives to the Games. This initially secured decent press coverage before being overshadowed by Westminster's announcement of the same decision. The work of our MSPs was noted and much appreciated by Tibet groups around the world.

Various protest activities took place in January 2022 in the run-up to the Beijing Winter Olympics. CS spoke at a rally in Glasgow, which was jointly organised by Tibet Solidarity (led by EBR) and Scottish Hongkongers. EBR also arranged for political representation at a second rally in Edinburgh - on this occasion the speaker was Maggie Chapman from the Scottish Greens.

Uprising Day (10th March)

The annual event to commemorate Uprising Day is now organised by Tibet Solidarity with support from the CPGT and the local Tibetan community. RG spoke at the initial rally, which took place in front of St Giles Cathedral in Edinburgh. This was followed by a march through the city, a rally outside the Chinese Consulate and a social gathering at the Himalaya Cafe. CPGT group members participated alongside Tibetans, Hongkongers and Chinese dissidents.

Colonial Boarding Schools

Following the release of Tibet Action Institute's report, the CPGT invited Lhadon Tethong, TAI Director, to give a presentation on the colonial boarding schools in Tibet and the research process behind their report. The presentation was very moving as well as informative and the CPGT resolved to take further action on this issue.

8th World Parliamentarians' Convention on Tibet, 22/23 June

Although no MSPs from the CPGT were able to attend the convention in person, RG recorded a video message expressing the CPGT and Scotland's ongoing support for Tibet.

Festival of Politics, Thursday 11 August

"Information and disinformation: Controlling the narrative as a tactic of war – and peace"

The CPGT successfully applied for a place at the 2022 Festival of Politics and hosted an event on the opening day of the festival. This was chaired by RG and featured Tibetan scholar Dr Tsering Topgyal alongside three other speakers. The event was well attended and followed by a social gathering for CPGT members.
