Thursday 23rd January 2025

Chaired by Foysol Choudhury MSP and attended by Jeremy Balfour MSP. Attended by 49 representatives from non-MSP member organisations.

At this online only meeting, we started by hearing a report on the 2023 Scottish Household Survey from Debbie Maltman of Volunteer Scotland. We then heard from Sarah Boath from Community Health Exchange who discussed health inequalities and community empowerment. We then heard from Martin Christie of Dunnikier Park Community Gold, and from David McDonald of Creative Lives. The session ended with questions and reflections.

Thursday 20th March 2025

Chaired by Foysol Choudhury MSP and attended by Paul O'Kane MSP. Attended by 35 representatives from non-MSP member organisations.

At this online only meeting, we started by hearing an update from Sarah Latto of Volunteer Scotland regarding PVG Fees. The Scottish Government had recently announced their decision not to proceed with proposed introduction of PVG fee discounts for Qualifying Voluntary Organisations in place of the existing fee waiver. We then heard from Jason Henderson of SCVO who gave a presentation on SCVO's campaign for the introduction of Fair Funding settlements for third-sector organisations. We then heard from Glenn Liddall from People Know How who shared his experience of running a VIO. We then heard from Sarah Latto who delivered a presentation on volunteering participation rates, before closing with a question and reflections section with attendees.

Thursday 5th June 2025

Chaired by Jeremy Balfour MSP and attended by Miles Briggs MSP. Attended by 40 representatives from non-MSP member organisations.

At this hybrid meeting held in Scottish Parliament Committee Room 2, we started with a presentation from Bethany Sikes from Volunteer Scotland, who spoke about a new piece of Volunteer Scotland research on the Social Value of volunteering, which found that volunteering brought combined £2.3 billion in economic and social

value to Scotland per year. We also had guest speakers from Georgia Artus, Director of Vintage Vibes, and Natalja Zukova, one of their volunteers, as well as Rachel Farmer, Volunteering Adviser with RNLI, as well as Sophie Cheney, Arbroath Crew Member. These guests delivered presentations which demonstrated that volunteering provided wellbeing opportunities for both the beneficiaries and the volunteers themselves.

Thursday 12th November 2025

Chaired by Jeremy Balfour MSP and attended by Foysol Choudhury MSP. Attended by 36 representatives from non-MSP member organisations.

At this online only meeting on the topic of An Inclusive Future for Volunteering, we started by hearing from Volunteer Scotland's Debbie Maltman who provided an overview of the 2024 Scottish Household Survey results. We also heard from Charlotte Jones from RNIB, and Daniel Bustillos-Arell, who each delivered presentations sharing their experience of accommodating volunteers with reasonable adjustments, and the challenges that create barriers to entry for disabled and deprived communities. Ewan Macleod from Volunteer Scotland finished by previewing the No Volunteers, No Community campaign.
