Joint meeting on 08/12/2024 with the CPG on Social Enterprise and the CPG on Circular Economy

In the meeting the group discussed the role of economic democracy in building a Wellbeing Economy and was held online. Members heard contributions from Professor Robert McMaster (Glasgow University), Neil McInroy (Democracy Collaborative), Susan Pinkney (Carnegie UK), Lucinda Broadbent (media co-op) as well as Michael Cook (Circular Communities Scotland). The speakers then discussed audience questions in a panel discussion. The meeting was attended by 5 MSPs, including 3 MSP members of the CPG on Wellbeing Economy and 2 other MSPs. In addition, the meeting was attended by 50 non-MSPs representing group members and invited guests.

Meeting on 23/04/2025

In the meeting, held as a hybrid meeting, group members discussed the proposal for a National Community Wealth Fund for Scotland. Dr Josh Doble, Policy Manager at Community Land Scotland, presented the proposals for a National Community Wealth Fund for Scotland developed by the Scottish Community Coalition on Energy. The proposal was then discussed by panellists from Future Economy Scotland, SSEN Transmission and Foundation Scotland, before the speakers answered audience questions. The meeting was attended by 3 MSP members of the group, as well as 51 non-MSPs representing group members and invited guests.
