2 Presentation by Jessica Mandanda

Jessica Mandanda, Feminist Macro-economic Alliance Malawi, will talk about the movement towards a feminist Wellbeing Economy in Malawi.

Jessica Mandanda is an Advocacy Communications Specialist with expertise in economic justice and rights. Her experience includes analysing the gendered impact of austerity on public services, and campaigning for an economy that works for women, regionally and internationally. Jessica is an alumnus of the Feminist Economics Summer School, African Macroeconomics Academy Malawi and a member of FEAM Malawi.

Heather has worked in the violence against women sector for 20 years in a variety of roles including delivering support to women, children and young people, delivering training and awareness raising.

Dr Gemma Bone Dodds is a political economy and systems change specialist dedicated to transforming the economy to serve society and the environment. She is speaking in her capacity as a Trustee of the Wellbeing Economy Alliance Scotland. Gemma is also a Senior Fellow at the Financial Innovation Lab, has a PhD in diverse economies and has published on transforming banking and finance.
