Item 1. Welcome

- Monica Lennon (ML) welcomed attendees to the meeting.
- ML paid tribute to the late Emma Ritch for her contribution to championing women's issues, including women's health.
- ML confirmed that the purpose of the CPG is "To inform Parliament and policymakers on a range of health issues which only, predominantly or disproportionately affect women; to consider the impact which gender and inequalities has on women's health and their ability to access healthcare and treatment and to empower women to make informed choices about their health and ensure they are treated with dignity and respect."

Item 2. Election of office bearers

- Monica Lennon MSP was re-elected Convener of the group.
- Rachael Hamilton MSP was elected Deputy Convener of the group.
- It was agreed that the Secretariat will be appointed at a subsequent meeting.

Item 3. Topics for future meetings

- ML noted that in the last session, the CPG covered the following topics:
 - My Body Back project (cervical screening, contraceptive care, STI testing and maternity care for people who've experienced sexual violence.
 - Menopause and the workplace
 - Endometriosis
 - o Lipoedema
 - Heart health
 - o Pause programme and conditional healthcare
 - o The impact of the pandemic on women's health
 - Miscarriage care
 - o The healthcare experience of Black and Minority Ethnic women
 - Heart Health (joint meeting with CPG on Heart & Stroke)
 - Mental health
- There were a number of suggestions from the group about future topics, including:
 - Scrutiny of the SG Women's Health Plan, including the exploration of the need for legislative underpinning
 - Menopause in the workplace (It was noted that Collette Stevenson MSP is currently seeking a member's debate on this topic)
 - o Peri-menopause
 - Mental health link with menstrual health
 - o Lack of funding for research into women's health
 - Women's health links with un/employment
 - Women's health for women in rural and remote areas.
