- Seek a Scottish Government Debate to call for a long term commitment to support woodland creation. This is to be complemented by a suite of parliamentary interventions.
- Invite Forestry and Land Scotland and Scottish Forestry to a future meeting of the CPG to emphasise the hectarage of land lying fallow.
- Creation of a press release to highlight the need for more attention and recognition to be given to the sector during the next Parliament giving emphasis to the imperative need for more commercial species.
- Agree strategy for working with the UK wide Tree Planting Task Force
 - Seek a meeting for the Convener with Ken Skates MS in the Senedd and the office bearers of the All Party Parliamentary Group in Westminster.
