GUIDE TO INFORMATION PUBLISHED BY THE SCOTTISH PARLIAMENT AND THE SCOTTISH PARLIAMENTARY CORPORATE BODY 2017

Produced as required by the Freedom of Information (Scotland) Act 2002

Section 23 of the Freedom of Information (Scotland) Act 2002 (FOISA) places a duty on Scottish public authorities to adopt and maintain a Publication Scheme which must specify:

- classes of information the authority publishes or intends to publish;
- the manner in which this information will be made available to the public free or on payment of a charge

The Scottish Parliament and the SPCB have adopted the Model Publication Scheme 2018 developed and approved by the Scottish Information Commissioner and last updated in November 2018.

It is impractical to make a distinction between the information held by the Scottish Parliament and the Scottish Parliamentary Corporate Body and therefore this includes information held by both.

The model publication scheme we have adopted requires us to publish information in the following categories or classes:

Class 1: About the authority

Class 2: How we deliver our functions and services

Class 3: How we take decisions and what we have decided

Class 4: What we spend and how we spend it

Class 5: How we manage our human, physical and information resources

Class 6: How we procure goods and services from external providers

Class 7: How we are performing

Class 8: Our commercial publications

Class 9. Our open data

It also enables senior colleagues to share expertise and knowledge and to contribute their views on how the organisation should be run, both currently and with an eye to the longer term.





Bills

Bills are draft laws that can be introduced by a member of the Scottish Government, a parliamentary committee, or an individual member of Parliament. The Scottish Parliament publishes every Bill introduced in the Scottish Parliament. Documents available vary according to the Stage reached by a Bill and may include the Bill (As Introduced), Explanatory Notes and Policy Memorandum, Marshalled Lists of Amendments, Groupings of Amendments, the Bill (As Amended at Stage 2) and the Bill (As Passed). For Bills no longer in progress, the documents available will include whichever of the documents listed above were published prior to the point when the Bill was enacted, withdrawn or fell.

Click on the name of the Bill you are interested in for the text of the Bill, documents relevant to the Bill, and details on the Bill's current progress.

The <u>Public Bodies Act 2011</u>, which received Royal Assent on 14 December 2011, was subject to a legislative consent motion in the Scottish Parliament in March 2012 (<u>Public Bodies Bill [HL]</u>). This Act includes order-making powers designed to enable UK Ministers to take forward the <u>proposals</u> announced on 14 October 2010 for the reform of a substantial number of public bodies for which the UK Government is responsible. Section 9 of the Act includes a requirement for the Scottish Parliament's consent to be sought for any provisions in an order made under Sections 1 to 5 of the Act which would

fall within the Scottish Parliament's legislative competence.
