## Report of the 75<sup>th</sup> Nordic Council Session 30 October- 3 November 2023 Oslo, Norway



### Introduction

1. The 75th Nordic Council Session took place in Oslo, Norway on 31 October- 2 November 2023. The theme of the Session was “A secure, green and young Nordic Region”.
2. The annual session brought together over 700 parliamentarians, parliamentary staff and institutions from across the Nordic region to address issues facing parliaments today. The Session offered the opportunity for Members to benefit from learning, networking, professional development and the sharing of best practice with colleagues from the Nordic parliaments and international guests.
3. Deputy Presiding Officer Annabelle Ewing MSP; Ben Macpherson MSP, Deputy Convener of the Net Zero, Energy and Transport Committee and Member of the Education, Children and Young People Committee; and Beatrice Wishart MSP, Deputy Convener of the Rural Affairs and Islands Committee represented the Scottish Parliament at the Session.

### Recommendations

- IRO has shared the information gathered during the meeting between the Deputy Presiding Officer and the First Deputy Speaker of the Swedish Parliament with relevant colleagues in the Scottish Parliament. As a result, a meeting between the Clerk/Chief Executive of the Scottish Parliament and

the Director of the Swedish Parliament is being organised to discuss shared challenges and examples of best practices.

- Ben Macpherson MSP and Beatrice Wishart MSP are intending to share the information learnt during the meeting with the Chairman and Deputy Chairman of the Committee for a Sustainable Nordic Region with their colleagues on the Rural Affairs and Islands Committee and Net Zero, Energy and Transport Committee. Furthermore, IRO has shared the information gathered during this meeting with colleagues across the Scottish Parliament working in these areas.
- Following the meeting with the Chairman of the Committee for Welfare in the Nordic Region Ben Macpherson MSP has offered to connect the Violence Reduction Unit with those working to address the gang violence challenges in Sweden and elsewhere in the Nordics. Also, IRO has shared the information gathered during this meeting with colleagues across the Scottish Parliament working in these areas.
- During the Deputy Presiding Officer's meeting with the Second Deputy Speaker of the Faroese Parliament he invited the Scottish Parliament to visit the Faroese Parliament. IRO has shared the information gathered during the meeting with relevant colleagues in the Scottish Parliament.
- Following the delegation meeting Kristina Háfoss, Secretary General of the Nordic Council, the Scottish Parliament has been invited to attend next year's Nordic Council Session in Iceland. IRO has also shared the information gathered during this meeting with relevant colleagues in the Scottish Parliament.
- Once the Nordic Council's committees have agreed their work programmes for 2024 IRO will share these with the Scottish Parliament's committees to see if there are any opportunities for knowledge exchanges.
- Following the Deputy Presiding Officer's meeting with the President of the Baltic Sea Parliamentary Conference (BSPC) the Scottish Parliament has been invited to attend the BSPC in Denmark next year. IRO has also shared the information gathered during this meeting with relevant colleagues in the Scottish Parliament.
- The Members were interested in setting up a video booth in the Scottish Parliament for events and IRO have shared this idea with the Parliament's Communications Office.

## **Purpose**

1. The primary purpose of the visit to Oslo was to attend the 75th Nordic Council session and showcase the Scottish Parliament's wish to increase our collaboration with the Nordic Council and the parliaments in the region.
2. The second aim of the visit was to meet with delegates from parliaments and international organisations attending the conference to develop bilateral relations and identify topics for potential knowledge exchanges.
3. The third aim of the visit was to provide Members with development opportunities by speaking to their counterparts in other parliaments and share best practice examples.

## Background

4. The Nordic Council is the official body for formal inter-parliamentary co-operation. Formed in 1952, it has 87 members from Denmark, Finland, Iceland, Norway, Sweden, Faroe Islands, Greenland and Åland. The main aim of the Nordic Council is to make the Nordic Region one in which people want to live and work. Members take part in the different committees to bring forward ideas and recommendations which are then debated in the annual plenary.
5. There are six committees:
  - The Presidium
  - Committee for Knowledge and Culture in the Nordic Region
  - Committee for a Sustainable Nordic Region
  - Committee for Growth and Development in the Nordic Region
  - Committee for Welfare in the Nordic Region
  - The Control Committee
  - The Election Committee

## Programme

**Tuesday 31 October 2023**

### Opening of the 75th Plenary Session of the Nordic Council and Plenary

7. The opening of the Plenary Session included a welcome from Masud Gharakhani, President of the Norwegian Parliament and Jorodd Asphjell, President of the Nordic Council 2023. This was followed by formalities including the approval of the list of delegates, standing orders for the 75<sup>th</sup> Session and agenda.
8. Following this, there was a guest speech by Jens Stoltenberg, Secretary-General of NATO. There was then a debate where members could ask questions to the Secretary-General.
9. *“Speaking about defence and the conflicts in the Middle East and Ukraine in his opening speech, Jens Stoltenberg, NATO’s Secretary General, referenced the situation whereby the entire Nordic region will soon be in NATO. (Mr Stoltenberg visited Shetland in 2012 when he was Prime Minister of Norway to formally open the Scalloway Museum, recognising the long-standing cultural links between the islands and his country.) The discussions around defence were robust, particularly on working together across the region on ongoing security. That also led to discussions about cable vulnerability in the region, something that resonates with Scotland’s Northern Isles.” - Beatrice Wishart MSP*

10. *“The address from the Secretary General of NATO provided a very interesting and important start to the proceedings, particularly given the international context with the conflicts in Gaza and Ukraine.”- Ben Macpherson MSP*
11. The third agenda item was the Nordic Summit with the Prime Ministers and heads of government. During this agenda item Prime Ministers from all eight member states gave a short speech outlining their intentions on how to make the Nordic Region the most sustainable and integrated region in the world and were then asked questions from the members of the Nordic Council. Any member was able to direct a question to any of the eight prime ministers.
12. Finally, the plenary concluded with the programme for the Swedish Presidency of the Nordic Council of Ministers 2024.

#### Meeting with Kenneth G Forslund, First Deputy Speaker of the Swedish Parliament

14. In the afternoon, Deputy Presiding Officer Annabelle Ewing MSP met with Kenneth G Forslund, First Deputy Speaker of the Swedish Parliament. They discussed question time, the role of a Speaker and Deputy Speaker, priorities for the current sessions, parliamentary creches and the importance of respectful debates.
15. **IRO has shared the information gathered during this meeting with relevant colleagues in the Scottish Parliament. As a result, a meeting between the Clerk/Chief Executive of the Scottish Parliament and the**

16. In the afternoon, Beatrice Wishart MSP as Deputy Convener of the Rural Affairs and Islands Committee and Ben Macpherson MSP as Deputy Convener of the Net Zero, Energy and Transport Committee met with Ola Elvestuen, Chairman and Staffan Eklöf, Vice Chairman of the Committee for a Sustainable Nordic Region. They discussed the Nordic Council's aim to be the most integrated and environmentally friendly region in the world and Scotland's similar aspirations. They discussed the opportunities and challenges related to this ambitious goal including fishing policies, offshore wind and biodiversity issues, cleaner shipping routes, tidal energy, rising energy costs and residential heating sources.

17. *"The meeting with Norwegian member Ola Elvestuen, Chairman of the Committee for a Sustainable Nordic Region, and his deputy, gave an opportunity to discuss agriculture and environmental issues. My impression is that the region is way ahead of Scotland in terms of sustainable transport, and I was particularly interested when Mr Elvestuen described the high usage of electric transport in both private and business vehicles, and ferries in Norway. In a recent [debate in Parliament on ferry services](#) I was able to refer to those electric ferries in terms of reliable and low-emission transport."* - Beatrice Wishart MSP

18. *"We discussed the challenges of the transition to net-zero and especially building more offshore wind capacity. There was interest in Scotland's tidal energy innovation and development. More connections between Norway and Scotland were also a point of interest. It was relayed to us that in some Nordic countries energy is cheaper to purchase by consumers near where the energy is produced. This may be a useful policy to explore when considering reform of the UK energy market and transmission charging. The NZET Committee will consider if and how to establish formal and informal*

*ongoing dialogue with the Committee for a Sustainable Nordic Region. I hope this will happen and be interesting. There may be several areas for further dialogue and learning from each other. For example, we are considering the Circular Economy Bill at the moment and one of the points raised in our Stage 1 evidence is to create more consistency across Scotland's 32 Local Authorities and at the Nordic Council Session it has been stated that all across the Nordic Region there is consistency.”- Ben Macpherson MSP*

### **Wednesday 1 November 2023**

#### Plenary

23. On the second day the plenary sessions focused on reports from Ministers for Foreign Affairs; Defence; and Nordic Co-operation. The Nordic Council of Minister’s budget was scrutinised as was the work of the Nordic Council of Minister’s work on welfare in the Nordic Region.

#### International co-operation

24. Plenary concluded with speeches from International Guests and Deputy Presiding Officer Annabelle Ewing MSP gave a speech on behalf of the Scottish Parliament highlighting the similarities we share with the Nordic Region and our wish to collaborate more with the parliaments within the region. Other international guests included delegates from the Baltic Assembly, Benelux Parliament, Baltic Sea Parliamentary Conference, National Assembly of Québec, OSCE Parliamentary Assembly, Schleswig-Holstein Landtag, UK Parliament and Vestnordisk Råd.

Meeting with Eva Lindh, Chairman of the Committee for Welfare in the Nordic Region

25. In the morning Ben Macpherson MSP, Member of the Education, Children and Young People Committee met with Eva Lindh, Chairman of the Committee for Welfare in the Nordic Region. They discussed the Social Security Act, cost of living crisis, additional support needs and mental health support workers in schools. They also spoke about the consequences of lockdown versus not locking down and violence in classrooms.

26. *“We discussed how to best assist young people with additional support needs, in schools and wider society. It was communicated to me that the Nordic countries are experiencing similar challenges about capacity and demand compared to Scotland. It was stated that Sweden was experiencing its particular challenges because their school system is different, in that it is not fully state run. We also discussed gang violence in Sweden and I set out how the Violence Reduction Unit at Police Scotland had made a significantly positive impact in Scotland.”- Ben Macpherson MSP*

27. **Ben Macpherson MSP has offered to connect the Violence Reduction Unit with those working to address the gang violence challenges in Sweden and elsewhere in the Nordics.**

28. **IRO has shared the information gathered during this meeting with colleagues across the Scottish Parliament working in these areas.**



Meeting with Johan Dahl, Second Deputy Speaker of the Faroese Parliament

29. Deputy Presiding Officer Annabelle Ewing MSP met with Johan Dahl, Second Deputy Speaker of the Faroese Parliament. They discussed common industries and challenges of connectivity in rural areas.

30. **The Second Deputy Speaker of the Faroese Parliament invited the Scottish Parliament to visit the Faroese Parliament.**
31. **IRO has shared the information gathered during this meeting with the relevant colleagues in the Scottish Parliament.**



The Nordic Council Presidium and the Chairs of the Committees' Seminar and Reception for the International Guests

32. All international guests of the Nordic Council Session were invited to attend a seminar on the recent cyber security developments in the Nordic region and beyond. The session focused in particular on Artificial Intelligence challenges. The event was chaired by Helge Orten, Vice President of the Nordic Council and speakers included Lars Gjesvik, the Norwegian Institute of International Affairs and Ingerd Schou, Vice-President, PACE. Following the seminar guests were able to network and the Scottish Parliament delegation met with Kristina Háfoss, Secretary General of the Nordic Council and MNA Yves Montiny from the National Assembly of Québec.
33. *“A fascinating discussion on an issue that will have significant impacts. However, as one of the speakers emphasised, even when AI is working perfectly it will not be perfect, as it is only as accurate as the data it draws upon.”- Ben Macpherson MSP*
34. **When the delegation met with Kristina Háfoss, Secretary General of the Nordic Council she invited the Scottish Parliament to attend the Nordic Council Session in Iceland next year.**

## Thursday 2 November 2023

### Plenary

36. Today's plenary focused on the work of the Nordic Council's committees. The various committees presented their recommendations, which were followed by a vote.

37. *"The questioning of the Prime Ministers focused a lot on the international situation but it was also interesting to hear deliberations throughout the three days between parliamentarians, including on gang crime, renewable energy transition, climate change impacts, agricultural challenges and demographic issues with aging populations, as well as on other issues. It was also interesting to observe how the Faroe Islands and Greenland input into the deliberations, as part of the Nordic Council but not full members."*- Ben Macpherson MSP

38. *"In the plenary sessions, it was evident that most of the issues facing the Nordic region are similar to those that we face in Scotland. For example, concerns about children's mental health and wellbeing, violence against women and girls, climate change and sustainable tourism. I would add that I found the respectful way in which business was conducted during the plenary sessions refreshing, even when there was policy disagreement. I look forward to sharing some of what I learned during the visit in my work in the Scottish Parliament."*- Beatrice Wishart MSP



## Presidency 2024

39. The final item on the agenda was the election of the next President and Vice-President of the Nordic Council followed by the Icelandic programme for the Presidency of the Nordic Council 2024. Bryndís Haraldsdóttir was elected President and Oddný G. Harðardóttir was elected as Vice-President of the Nordic Council 2024. The Icelandic programme for the Presidency will focus on Peace and Security in the Arctic, as well as the environment and gender equality.
40. **Once the Nordic Council committees have agreed their work programmes for 2024 IRO will share these with the Scottish Parliament's committees to see if there are any opportunities for knowledge exchanges.**



## Meeting with Henrik Møller, President of the Baltic Sea Parliamentary Conference

41. In the morning, Deputy Presiding Officer Annabelle Ewing MSP met with Henrik Møller, President and Bodo Bahr, Secretary General of the Baltic Sea Parliamentary Conference (BSPC). They discussed the structure and work of the BSPC, the impact of climate change in the region, transferrable skills within the energy sector and explored potential areas of future collaboration.



42. **The Scottish Parliament has been invited to attend the BSPC in Denmark next year.**
43. **IRO has shared the information gathered during this meeting with relevant colleagues in the Scottish Parliament.**

#### Video message

44. Following the conclusion of the Session the Members of the delegation recorded a short video message to the Nordic Council, which can be seen on [IRO's X \(formerly known as Twitter\) page](#). They raise that we share many similar challenges and opportunities that were highlighted in the discussions in the plenary and look forward to further cooperation between the members and committees of the Nordic Council and the Scottish Parliament.

## **Conclusion**

49. Deputy Presiding Officer Annabelle Ewing MSP; Ben Macpherson MSP, Deputy Convener of the Net Zero, Energy and Transport Committee and Member of the Education, Children and Young People Committee; and Beatrice Wishart MSP, Deputy Convener of the Rural Affairs and Islands Committee represented the Scottish Parliament at the 75<sup>th</sup> Nordic Council Session in Oslo, Norway.
50. The Members took part in plenary sessions and networking events over three days. In addition to this, the Members held seven bilateral meetings with delegates from the Baltic Sea Parliamentary Conference, Denmark, Faroe Islands, Norway, Nordic Council, Québec and Sweden.
51. The visit allowed for in depth discussion and shared learning across a range of parliaments and topics. There were various recommendations/action points to take forward and the feedback from the Members showed it was a highly valuable visit. Members particularly enjoyed sharing best practices and developing relationships with colleagues across the Nordic region and further afield, enhancing their work as parliamentarians.
