

Fuel Poverty (Target, Definition and Strategy) (Scotland) Bill

Groupings of Amendments for Stage 2

This document provides procedural information which will assist in preparing for and following proceedings on the above Bill. The information provided is as follows:

- the list of groupings (that is, the order in which amendments will be debated). Any procedural points relevant to each group are noted (including, for those amendments ruled by the Presiding Officer to have a potentially significant cost that would bring the costs of the Bill to over £400,000 in any single financial year, the cost for each amendment);
- the text of amendments to be debated at Stage 2, set out in the order in which they will be debated. **THIS LIST DOES NOT REPLACE THE MARSHALLED LIST, WHICH SETS OUT THE AMENDMENTS IN THE ORDER IN WHICH THEY WILL BE DISPOSED OF.**

At introduction the Presiding Officer determined that a financial resolution was not required for this Bill. Under Rule 9.12.6C, it is for the Presiding Officer to determine whether an amendment either individually or in combination with other amendments, cause (or might cause) the Bill, to which they relate, to require a financial resolution which it would not otherwise require. The Presiding Officer has ruled that the costs associated with amendments 48 and 62 would in themselves be significantly more than £400,000 (the current threshold for what is considered significant) and for them to be agreed the Bill would require a financial resolution. Amendments 48 and 62 may be debated, but may not be agreed to in the absence of a financial resolution.

The Presiding Officer has also ruled that amendments 93, 31, 81, 84, 82 and 85 are cost bearing amendments. However, the potential cumulative cost of those amendments would not lead to the cost of the Bill exceeding £400,000 in any single financial year. As such, these amendments, and any amendments consequential on those amendments, may be debated and the question put on them.

- (1) The Scottish Fuel Poverty Advisory Panel (in this Act referred to as “the Panel”) is established.
- (2) The Panel is to meet after the publication of each periodic report under section 8 in order to consider the matters mentioned in subsection (3).

 - (d) make such other provision about the functioning of the Panel as the Scottish Ministers consider appropriate.
