#### Who we are



We are the **Education**, **Children** and **Young People Committee** of the **Scottish Parliament**.



A **committee** is a small group of people who are **Members of the Scottish Parliament**, also called **MSPs**.



The Scottish people decide who is an MSP by voting for them in elections.



The **Scotlish Parliament** makes **laws** in Scotland.



**Laws** are rules that tell people what they can or cannot do.



They protect people and make sure everyone is treated in a good and fair way.



The Scottish Parliament also checks what the **Scottish Government** is doing.



The **Scottish Government** decides how to run the country.



The Scottish Government and the Scottish Parliament are separate organisations.

#### What this booklet is about



This booklet is about a new bill. A bill is a document that could become a law.



The Bill is called the **Restraint and Seclusion in Schools (Scotland) Bill.**The idea for the Bill came from an MSP called Daniel Johnson.

The Bill will become part of the law in Scotland if the other MSPs agree with it.

#### What the Bill is about



The Bill is about ways to help schools use **techniques** called **restraint** and **seclusion** less.



A **technique** is a certain way to do something.



**Restraint** means stopping someone from moving.



**Seclusion** means putting someone in a place on their own and stopping them from leaving.



Restraint and seclusion techniques might be used when children and young people behave in a difficult way or in a way that needs to be controlled.



Daniel Johnson MSP thinks restraint and seclusion techniques could be used less.



He thinks that if school staff had the right guidance and training, they would be able to

- de-escalate problems
- use the right techniques for different problems.



For the Bill, **de-escalate** means finding ways to calm children and young people down so restraint and seclusion techniques are used less.



This might include listening to them to find out why they are upset.

The Bill says the Scottish
Government must make statutory
guidance and duties about how
restraint and seclusion techniques
should be used in schools.



**Statutory** means something decided by law.



**Statutory guidance** is when the Government says how something should be done.



**Statutory duties** are things the law says people or organisations must or must not do.



The statutory guidance and duties would have to be followed by all types of schools, but not nursery schools.



People in charge of schools would have to think about the statutory guidance and duties when they write or change **policies**.



**Policies** are ideas or plans an organisation can follow about how something should be done.



For the Bill, a school policy might say that a person must have special training before they are allowed to use restraint on another person.



**The Bill says** schools must tell parents or carers when they use restraint or seclusion techniques on their child.



They must tell them what happened. They must do this within 24 hours of when the techniques were used.





**Record** means write information down and keep it somewhere it can be looked at.



The information that is recorded must be sent to the Scottish Government.





At the end of each year, the Scottish Government must write a report on all the information it has been sent and send this report to the Scottish Parliament.



This helps show how much restraint and seclusion techniques are being used in schools in Scotland.



It also helps the Scottish Government and schools think about how they can use restraint and seclusion techniques less in the future.



The Bill says the Scottish
Government must make a list of people who give training about how to use restraint and seclusion techniques in schools.



They must make sure the list is up to date.



The list must include information about the courses and training school staff should do.



All school staff who are likely to spend time with children and young people who might have restraint or seclusion techniques used on them should do the training.



 information about someone else that could tell other people who they are, like their name, address or where they work.




offensive language.


## The survey What we want you to tell us
