Previous minutes

1. The SPCB agreed the minutes of the meetings held on 19 June and 2 September 2025.

Matters arising

- 2. The SPCB received an update on the actions the Parliament has taken in response to the ongoing criminal investigation into a Member. It also received an updated on the independent review of complaints.
- 3. The following items were dealt with by correspondence since the meeting on 19 June 2025—
 - Paper 36: The SPCB approved recommendations from the Senior Executive Team regarding a Member's access to Holyrood and participation in parliamentary business.

 - An update from the Clerk/Chief Executive regarding a modification to the Parliament's Education Service.
